ORDER

WHEREAS in terms of Section **15(1)** of the NCTE Act, 1993 **Maulana Azad Institute of Humanities, Science & Technology, VPO- Mahmudabad, Tehsil- Mahmudabad, District- Sitapur, Uttar Pradesh**, had submitted an application to the Northern Regional Committee of NCTE, Jaipur for grant of recognition/permission for starting **B.P.Ed Course** of **One year** duration with an annual intake of **50 (Fifty Only)** students on **13.11.2007**.

2. AND WHEREAS the original file of the institution as well as other documents and materials submitted by the institution along with VTR videography were duly considered by the NRC in its 131st (3rd Sitting) Meeting held on 29th - 31st August, 2008 respectively, the committee decided to issue Letter of 7(9) as per Regulation, 2007 to the institution and accordingly 7(9) as per the Regulation, 2007 was issued vide NCTE letter no. **F.NRC/NCTE/F-7/UP-2678/2008/60718-19 Dated 04.09.2008**.

3. AND WHEREAS the applicant institution has submitted representation to Northern Regional Committee, NCTE, Jaipur and the matter was placed before NRC in its 141st Meeting held on **22nd to 24th May 2009** and the committee decided to refuse the recognition for B.P.ED course of one year duration. Accordingly order of refusal was issued vide order no. **F.NRC/NCTE/F7/UP-2678/141 MEETING/2009/2682-88 dated 16.07.2009**. The above said institution, thereafter preferred an appeal dated **16.06.2009** to the NCTE, New Delhi. Under section 18 of the NCTE Act 1993 against the aforesaid order.

4. AND WHEREAS after perusal of documents, memorandum of appeal, affidavit and after hearing oral arguments advanced during the hearing, the NCTE, New Delhi, reached the conclusion that there was adequate ground to accept the appeal, and accordingly remanded back the matter to NCTE NRC with the direction to issue the order of recognition to the institution, in its order no. **F.NO. 89-565/2009 -APPEAL dated 07.08.2009**.

5. AND WHEREAS the matter was again placed before the NRC NCTE in its 148th Meeting held on 28th - 30th August, 2009 and the committee noted the decision of the appeal committee. Subsequently the order of recognition under section 15(1) of the NCTE was issued vide order dated 6.11.2009. Again the institution preferred an appeal under section 18 as it was not satisfied with the session mentioned in the order. Vide its order dated 12.02.2010 the appellate authority (Council) after considering the submission made by the appellant and also to protect the interest of the passed out students for the session 2008-2009, the council arrived at a conclusion that the formal recognition to the institution may be granted in continuation of the Letter of intent prior to recognition letter dated 04.09.2008.

6. NOW, THEREFORE, in exercise of the powers vested under Section **15(3) (a)** of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to **Maulana Azad Institute of Humanities, Science & Technology, VPO- Mahmudabad, Tehsil- Mahmudabad, District- Sitapur, Uttar Pradesh** for conducting **B.P.ED course** of **Secondary Physical (Level)** of **One year** duration with an annual intake of **50 Students (Fifty only)** students in continuation of the conditional recognition letter dated 04.09.2008.

7. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.

8. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

9. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.
10. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.
11. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.
12. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
13. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -
- Copy of the Application Form
 - Land and Building Particulars
 - Staff Profile
 - Recognition letter
 - Information for having fulfilled the norms & standard and other required conditions.
14. In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
