ORDER

WHEREAS, Maharishi Dayanand Management College, VPO- Loni, Tehsil- Ghaziabad, District- Ghaziabad, Uttar Pradesh was recognized for B.Ed course with annual intake of 100 seats by the NRC NCTE vide its order No. F.NRC/NCTE/F-7/UP-2820/2008/61135-41 dated 05.09.2008.

AND WHEREAS, the applicant institution has submitted a request for change of name of the institution vide its letter dated 05.03.2010 received by this office on 10.03.2010.

AND WHEREAS, the matter was placed before the committee in its 159th meeting held from April 28-May-01, 2010 and the committee decided not to permit the Institute to change its' name from Maharishi Dayanand Management College, VPO- Loni, Tehsil- Loni, District- Ghaziabad, Uttar Pradesh to Maha Devi Mahila College, VPO- Loni, Tehsil- Loni, District- Ghaziabad, Uttar Pradesh, in the absence of any valid reason. Accordingly, order issued on 14.05.2010.


AND WHEREAS, the above said Institution, thereafter preferred an appeal dated 19.05.2009 to the NCTE, New Delhi under section 18 of the NCTE Act, 1993 against the aforesaid order. The Council vide order dated 29.09.2010 reached the conclusion that there was no ground to accept the appeal for change of name of the institution and directed NRC to restore the recognition to the institution for conducting the B.Ed. course in the name of Maharishi Dayanand Management College.

AND WHEREAS, the matter was placed in the 175th Meeting held on December 30-31, 2010 and it was decided that as per direction of the Appellate Authority, the recognition order of the institution in the original name of Maharshi Dayanand Management College, Loni, Ghaziabad, U.P be restored. Separately, the institution be asked to give detailed reason for making the institution as 'Only for girls' alongwith no objection from the State Government and the Affiliating Authority to do so.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby restores recognition granted to Maharishi Dayanand Management College, VPO- Loni, Tehsil- Ghaziabad, District- Ghaziabad, Uttar Pradesh for conducting B.Ed. Course of Secondary (Level) One-year duration with an annual intake of 100 (One hundred Only) seats vide order No. F.NRC/NCTE/F-7/UP-2820/2008/61135-41 dated 05.09.2008.

The other terms and conditions will remain same as mentioned in the recognition order dated 05.09.2008.
