#### RECOGNITION ORDER

AND WHEREAS on scrutiny/perusal of veracity of the facts & figures as per the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of visiting team report including videography and also the reply submitted by the institution against letter of 7(9), the Northern Regional Committee in its 201<sup>st</sup> meeting held on July 12<sup>th</sup> to 15<sup>th</sup>, 2012 is satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the D.El.Ed. programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory, etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

  - (i) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
  - (ii) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
  - (iii) The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- 4. Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.
