ORDER OF RESTORATION OF RECOGNITION

WHEREAS, Recognation to Ambrish Sharma College of Education and Technology, Ghosipur, Hapur Road, Meerut, Uttar Pradesh was granted for running B.P.Ed. Course for One Year duration with an annual intake of 50 (Fifty Only) seats vide order No.- NRC/NCTE/F-7/8314-8339 & 8371-8379 dated 14.11.2006 subject to certain conditions.

AND WHEREAS, the recognition of the Institution was refused vide order No. NRC/NCTE/F-3/UP- $2012/172^{nd}$ Meeting/2010/1014-1020 dated 04.12.2010.

AND WHEREAS, the institution had preferred an appeal dated 03.02.2011 to the NCTE, New Delhi under section 18 of the NCTE Act, 1993 against the aforesaid order. The Council vide order dated 04.01.2012 accepted the appeal and reversed NRC's order dated 04.12.2010 and after perusal of documents, memorandum of appeal, affidavit, VT report and after considering oral arguments advanced during the hearing, the Council reached the conclusion that there was adequate ground to accept the appeal with the direction to the NRC for giving 3 months time to the institution for appointing qualified and experienced Principal as per NCTE Norms and for taking further decision thereafter. The Council hereby remands back the case of Ambrish Sharma College of Education and Technology, Meerut, Uttar Pradesh to the NRC, NCTE for necessary action with reference to appeal order the institution has submitted List of Faculty vide letter dated 17.02.2012 & 03.09.2012.

AND WHEREAS, the matter was place before NRC in its 205^{th} Meeting held on September 28^{th} to 30^{th} , 2012 and NRC decided that the recognition of B.P.Ed. course of the Institution be restored.

NOW THEREFORE, In exercise of powers vested under NCTE Act, 1993 Northern Regional Committee is hereby restore the recognition of Ambrish Sharma College of Education and Technology, Ghosipur, Hapur Road, Meerut, Uttar Pradesh for B.P.Ed. Course.
