The institution has filed writ petition no. 37737/2010 before Hon'ble High Court of Allahabad against decision of NRC.
- 2. AND WHEREAS, in compliance of order dated 02.07.2010 Passed by the Hon'ble High Court of Allahabad in the said petition the matter was considered by NRC in its 212<sup>th</sup> Meeting and it was decided that the recognition of the said institution shall be continued.
- 3. AND WHEREAS, the said institution has also applied for change the name of the institution from J.P.C.L. Degree College to Manohar Lal Mahavidhyalaya. The state Government has granted permission for change the name vide leter dated 11.03.2004. The request submitted by the institution for the change the name of the institution was considered by NRC in its 212<sup>th</sup> meeting held on 28<sup>th</sup> February, 2013, and it was decided that the permission of change name of College of J.P.C.L. (Manohar Lal) Degree College to Manohar Lal Mhavidhyalaya be granted.
- 4. NOW THEREFORE, in terms of above decision of NRC the recognition of above institution is hereby continue and permission to change the name of the institution from J.P.C.L. (Manohar Lal) Degree College to Manohar Lal Mahavidhyalaya is also granted.
