ORDER

WHEREAS in term of section 14(1) of the NCTE Act, 1993 **Chaudhary Ram Chritra Prameshware Prasad Mahavidhyalaya, Moondadiha Khurd, Post-Puraina, Mansoor, Tehsil, Rudhali, District-Basti-272001, Uttar Pradesh.** had applied for grant of recognition for B.Ed course of one year duration with an annual intake of 100 (one hundred only) students on **30.10.2008.**

AND WHEREAS, the application was processed and the inspection of the said institution under section 14 was conducted on **30.01.2010.** The VTR was considered by NRC in its 157<sup>th</sup> Meeting held from March 24-27, 2010 and the NRC decided to issue show-cause notice to the institution. Accordingly, show cause notice was issued to the institution on 31.03.2010 on certain grounds.

AND WHEREAS, the reply submitted by the institution in response to the points of show cause notice, was considered by the NRC in its 161<sup>st</sup> meeting held from May 26-29, 2010 and NRC decided that VT may be sent to verify the deficiencies met. Accordingly, letter was issued to the institution on 4.08.2010.

AND WHEREAS, the re- inspection of the institution u/s 14 of NCTE Act was conducted on **10.08.2010.** The VTR was considered by the NRC in its 180<sup>th</sup> meeting held from March 23-26, 2011 & 31<sup>st</sup> March to 1<sup>st</sup> April to 9, 11 April, 2011 and NRC decided to issue LOI, prior to recognition under clause 7(9) of the NCTE Regulation. Accordingly, letter under clause 7(9) was issued to the institution on 9.05.2011.

AND WHEREAS, the reply submitted by the institution in response to the letter of 7(9), was considered by the NRC in its 184<sup>th</sup> meeting held from 27<sup>th</sup> June to 1<sup>st</sup> July, 2011, and NRC **decided that formal recognition Under Clause 7(11) of the NCTE Regulations be issued for 100 seats of B.ED. Course from the academic session 2011-12.**

NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(b) of the NCTE Act, 1993, the Northern Regional Committee hereby grants the recognition to **Chaudhary Ram Chritra Prameshware Prasad Mahavidhyalaya, Moondadiha Khurd, Post-Puraina, Mansoor, Tehsil, Rudhali, District-Basti-272001, Uttar Pradesh.** for **B.ED Course with an intake of 100 (one hundred only) seats under clause 7(11) of NCTE Regulation 2009 from the academic session 2011-12 subject to the following conditions:-**

- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2009.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made or issued, there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act 1993.
