RECOGNITION ORDER

WHEREAS in terms of section 14(1) of the NCTE Act, 1993, Vansh Educational Charitable Trust, Plot Number- 2/144, Street/Road- M G Road, Village/Town/City- Agra, Post Office- Collectrate, Tehsil/Taluka- Agra, Town/City- Agra, District- Agra, Pin Code- 282001, State- Uttar Pradesh has submitted on application (Code No. NRCAPP-2641) to the Northern Regional Committee of NCTE for grant of recognition for conducting D.EL.ED. Course with an annual intake of 50 (Fifty Only) on dated 04.10.2011 in the name i.e. S K V Academy, Plot Number- 225 & 226, Street/Road- NH-2, Village/Town/City- Dharrara, Post Office- Etmadpur, Tehsil/Taluka- Agra, Town/City- Agra, District- Agra, Pin Code- 282006, State- Uttar Pradesh.

2. AND WHEREAS on scrutiny/perusal of veracity of the facts & figures as per the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of visiting team report including videography and also the reply submitted by the institution against letter of 7(9), the Northern Regional Committee in its 220th Meeting of the NRC held from 25th October, 2013 to 29th October, 2013, is satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the D.EL.ED. Programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory, etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to S K V Academy, Plot Number- 225 & 226, Street/Road- NH-2, Village/Town/City- Dharrara, Post Office- Etmadpur, Tehsil/Taluka- Agra, Town/City- Agra, District- Agra, Pin Code- 282006, State- Uttar Pradesh for conduction D.EL.ED. Course of Elementary (Level) of Two Year duration with an annual intake of 50 (Fifty Only) from the academic session 2014-2015 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject to fulfilment of the following conditions:-

- (i) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- (ii) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
- (iii) The institution shall ensure that the required number of academic staff for conducting the course is always in position.

4. Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

6. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
