- NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition RRS College Of Education, Plot No. 15, Street No. - 77, Village - Azampur, Post Office - Azampur, Teshil/Taluka - Chandpur, Town/City - Bijnor, District - Bijnor, State - Uttar Pradesh, Pin Code - 246734 for conduction of B.Ed. course of Secondary level of one year duration with an annual intake of 100 (One Hundred Only) from the academic session 2014-2015 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject to fulfillment of the following conditions:-
 - The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.
 - II. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
 - III. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

- In case if the land is in the name of the Society/trust, you must transfer the land within six months in the name of the institution failing which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate about the same to the respective Regional Committee along with the new land documents within the stipulated time.

- 8. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee shall withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
