# NORMS AND STANDARDS FOR DIPLOMA IN ELEMENTARY EDUCATION PROGRAMME LEADING TO THE DIPLOMA IN ELEMENTARY EDUCATION (D.EI.ED.) - Regarding Staff

#### 5. Staff

## 5.1 Academic Faculty

For an intake of up two basic units of 50 students each, the Faculty strength shall be 16. The Principal or HOD is included in the faculty. The distribution of faculty across subject areas may be as under:

(i) If the students' strength for two years is one hundred only, the number of faculty shall be reduced to 8. The faculty in specialised areas and some of the pedagogic courses can be shared with the other teacher education programmes.

Faculty can be utilized for teaching in a flexible manner so as to optimize academic expertise (iii)

#### **Oualifications** 5.2

#### Principal / HOD Α

- Postgraduate degree in Sciences / Social Sciences / Arts/ Humanities with minimum 55% marks, and M.Ed./ M.A (Education) /M.El., Ed with minimum 50% marks.
- Five years teaching experience in a Teacher Education Institution. (ii) Desirable: Degree/ Diploma in Educational Administration / Educational Leadership.
- Perspectives in Education/Foundation of Education; & Curriculum and Pedagogy Β.

Teacher Education in D.El.Ed. should have Masters Degree in Social Science/ Humanities/ Science/ Maths/ Language with 50% marks, and M.Ed with 50% Marks or M.A (Education) with 50% marks where the requirement shall be positions Philosophy/Sociology/Psychology with 50% marks and B.El.Ed. or B.Ed. or D.El.Ed. with 50% marks, or M.Phil/Ph. D in Education

C., Physical Education

Masters degree in Physical Education (M.P.Ed.) with minimum 50% marks.

Visual and Performing Arts (D)

Masters degree in Fine Arts/ Music/ Dance/ Theatre with 50% marks.

## (b) Qualifications

In a composite institution, the Principal and academic, administrative and technical staff can be shared. There shall be one Principal, and others may be termed as HoDs.

### Terms and Conditions of Service

The terms and conditions of service of teaching and non-teaching staff including selection procedure, pay scales, age of superannuation and other benefits shall be as per the policy of the State Government/Affiliating body.

- (vi) As per decision of NRC taken in 240<sup>th</sup> meeting held on 20<sup>th</sup> to 22<sup>nd</sup> July, 2015, the institution shall ensure that it has become a composite institution before the commencement of the academic session 2016-17.
- 4. Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.
- 5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year alongwith the statement of annual accounts duly audited by a Chartered Accountant.
- 6. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
  - (i) Copy of the Application Form
  - (ii) Land and Building Particulars
  - (iii) Staff Profile
  - (iv) Recognition letter
  - (v) Information for having fulfilled the norms & standard and other required conditions.
- 7. In case if the land is in the name of the Society/trust, the land is to be transferred within six months in the name of the institution, failing which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate about the same to the respective Regional Committee along with the new land documents within the stipulated time.
- 8. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
- 9. Further, if the institution is not satisfied with the order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website <a href="www.ncte.india.org">www.ncte.india.org</a> within 60 days from the date of this order. The guidelines for filing appeal may be seen on NCTE's website.
