ORDER

- The shifting of the institution at new premises is permitted.

AND NOW, therefore, the institution, namely Smt Usha Singh Shikshan Prashikshan Sansthan is hereby permitted to shift its premises from Plot No.798ch, Village- Koro, Post Office-Bhikharpur, Tehsil-Sadar, District-Sultanpur, Uttar Pradesh to Khasra No.-1545, 1522 Village-Majhwara, Post-Mayang, Distt.-Sultanpur, Uttar Pradesh-228121 under clause 8(9) of the NCTE Regulations, 2014 for running its D.El.Ed. programme of two years duration.
