ORDER

WHEREAS, the recognition was granted to **Global Genius College, Plot No.- 552, Village- Sonkh, Post office- Sonkh, Tehsil/Taluka- Mathura, Town/City- Sonkh, Distt.- Mathura, Uttar Pradesh-281123** for D.El.Ed. course vide order No. NRC/NCTE/NRCAPP-15632/146821-7694 dated 02.05.2016 for 100 students (two units of 50 students each) from the academic session 2016-2017.

AND WHEREAS, the matter was considered by NRC in its 253rd (Part-1) Meeting held from 30th May to 03rd Jun, 2016 and the Committee decided of reduce the intake to one unit (50 students) from two units (100 students) under clause 7(16) of the NCTE Regulations, 2014 from the academic session 2016-2017.


Accordingly, Corrigendum was issued to the institution on 09.09.2016.

AND WHEREAS, the institution preferred an appeal before the Council under Section 18 of the NCTE Act, 1993. The Appellate Committee remanded the case to NRC vide its order setting aside the Corrigendum dated 09.09.2016 and to restore original intake of 100 seats.

AND WHEREAS, the Order was considered by NRC in its 277th Meeting held on 05th to 06th December, 2017. The Committee decided that "in compliance of the Order of the Appeal Committee, the recognition of the institution be restored to the original intake of 100 seats as mentioned in the recognition order dated 02.05.2016.

Now therefore, the recognition of **Global Genius College, Plot No.- 552, Village- Sonkh, Post office- Sonkh, Tehsil/Taluka- Mathura, Town/City- Sonkh, Distt.- Mathura, Uttar Pradesh-281123** for D.El.Ed.. course with an annual intake of 100 students (two units of 50 students each) granted vide order no. File No./NRC/NCTE/NRCAPP-15632/146821-7694 dated 02.05.2016 is hereby restored.
