## **ORDER**

WHEREAS, the recognition was granted to DSSA Balika Mahavidyalaya, Plot Number- 226Mi, 253, 256Mi, 108, 110Mi, 236, Street/Road- Dadanpur, Village/Town/City- Dadanpur Ahirouli, Post Office-Ariyaso, Tehsil/Taluka- Ghosi, Town/City- Mau, District- Mau(UP), State- UP, Pin Code- 275105 for B.Ed. course vide order No. File No./NRC/NCTE/NRCAPP-6764, 8878, 8427 & 6794/244th Meeting/130031-44 dated 25.11.2015 with an annual intake of 50 seats from the academic session 2016-2017.

AND WHEREAS, a letter dated 28.07.2016 was received from the Registrar Veer Bahadur Singh Purvanchal University, Jaunpur, Uttar Pradesh regarding withdrawal of recognition of B.Ed. course. The matter was considered by NRC in its 256th Meeting (Part-2) held on 22th August, 2016 and the Committee decided that Show Cause Notice under Section - 17 of NCTE Act, 1993 be issued to the institution before withdrawal of recognition on grounds mentioned in the letter. The copy of the letter be forwarded to the institution.

AND WHEREAS, Show Cause Notice was issued to the institution on 01.09.2016.

AND WHEREAS, the institution did not submit reply of Show Cause Notice. The matter was considered by NRC in its 264th (Part-1) Meeting held from 20th to 23th February, 2017 (20.02.2017) The Committee observed that the institution was granted recognition under clause 7(16) vide Order 25.11.2016. After recognition, NRC received letter from the Registrar, Veer Bahadur Singh Purvanchal University, Jaunpur. In the letter, the Registrar mentioned that the institution has been given recognition on fake faculty list. Hence, institution was given show cause notice. The reply submitted by the institution is not acceptable. The institution misled the NRC by submitting a fake list of teachers. The Committee, therefore, decided to withdraw the recognition of the institution for B.Ed. course under Section - 17 of the NCTE Act, 1993.

AND WHEREAS, Withdrawal Order was issued on 09.03.2017 to the institution.

AND WHEREAS, the Institution preferred an appeal before the Council (New Delhi) under section 18 of the NCTE Act, 1993. The Appellate Authority passed an order dated 10.07.2017.

AND WHEREAS, the matter was considered by NRC in its 273rd (Part-2) Meeting held on 26th to 27th July, 2017 and decided to issue Show Cause Notice to the institution on the following grounds: -

In compliance with the order of Appellate Authority dated 10.07.2017, the case was considered and the following observations were made:-

- The applicant institution has not submitted the copies of three letters thereby approving the faculty by Veer Bahadur Singh PurvanchalVishwavidyalya, Jaunpur as mentioned in the orders of the Appellate Authority.
- As directed by the Appellate Authority, the institution has not submitted the reason for getting a fresh list of faculty approved by the university in their letter dated 12.05.2016.

AND WHEREAS, the Show Cause Notice was issued on 03.08.2017 to the institution.
