**ORDER**

WHEREAS, recognition was granted by the Northern Regional Committee to Kalindi College of Education, Plot NO. - 820, Village - Malakpur, Post Office - Malakpur, Tehsil -Baraut, Dist - Bagpat, UP - 250611 vide Order No F. NRC/NCTE/ NRCAPP-4631/ Recognition/277<sup>th</sup> Meeting/2017 dated 08.12.2017 for B.Ed. course of two years duration with an annual intake of two units (s) of 100 students.

AND WHEREAS, the institution submitted an application, received in the NRC office on 08.01.2018 requesting for change of name of the institution from Kalindi College of Education to Kalindi College.

AND WHEREAS, the matter was placed before the NRC in its 279<sup>th</sup> meeting held from 16<sup>th</sup> to 17<sup>th</sup> January, 2018 and the Committee decided as under: -

- The request of the institution has been considered in the light of NCTE (HQ) letter No. F.No.49-3/2016/NCTE/N&S/47143 dated 08.12.2016 which *inter-alia* provides that "With respect to change of name of the institution, this may be permitted if the land is not transferred to the existing institution proposed to be changed. If the land is already transferred from Society to the institution or if the land is the name of the institution any change in the name of institution shall essentially require change in the ownership of the land. In this case processing fees may be charged for inspection process."

In the instant this, since the land is in the name of the sponsoring Society, the NRC decided that the institution may be permitted to change its name from Kalindi College of Education to Kalindi College.

NOW THEREFORE, the Northern Regional Committee hereby grants permission to the institution for change of its name from Kalindi College of Education to Kalindi College.
