## ORDER

Malwa College of Physical Education, Opp. NFL Township, Goniana Road, Bathinda, Punjab submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition of B.P.Ed. course of one Year duration in terms of section 14(1) of NCTE Act, 1993.

- WHEREAS the case of the institution was considered by the NRC in its 89th meeting wherein the Northern Regional Committee noted that the deficiencies communicated to the institution still persist with reference to the requirements as per the NCTE Regulations and therefore, the Regional Committee decided to refuse grant of recognition for the proposed B.P.Ed. course.
- AND WHEREAS the Appellate Authority of NCTE vide Order No. 89-84/2005-Appeal dt. 09.06.2005 decided to reverse the refusal order dated 06.04.2005 of NRC, Jaipur.
- Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act. 1993, the Regional Committee hereby grants recognition to Malwa College of Physical Education, Opp. NFL Township, Gonlana Road, Bathinda, Punjab for B.P.Ed. Course with an annual intake of 50 seats (Fifty seats), w.e.f. 11th July, 2005 subject to compliance of the following conditions before commencement of the academic session.
  - Appointment of the faculty members duly qualified and staff as per the norms of NCTE/ State Govt/UGC is to be completed before the commencement of the
  - The countersigned statement of all faculty members from the Registrar of the b. concerned University should be submitted before the commencement of the academic session
  - The institution shall adhere to all the other regulations and guidelines as framed C. by NCTE from time to time
  - d The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
  - That the Reserve Fund for an amount equal to three months salary of the G. Teachers & Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five years) in a Nationalized Bank.

f. Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NCTE Act, 1993

The Recognition is subject to the condition that the affiliating University shall ensure that, a state among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / UGC / Affiliating University.

- If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and/or order made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993.
