WHEREAS in terms of Section 15(1) of the NCTE Act, **Shivalik Hills College of Education, Vill - Patti, Post - Manakpur, Tehsil - Anandpur Sahib, Distt. - Roper, Punjab - 140125**, has submitted an application to the Northern Regional Committee of NCTE for grant of recognition for starting **ETT Course** of **two years** duration with an annual intake of **50 (Fifty only)** students on **15.06.2006**.

AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Northern Regional Committee in its 143rd meeting held on 27th - 29th June, 2009 decided to refuse recognition for ETT course. Accordingly, order was issued to the institution on 10.07.2009.

The institution preferred an appeal to the NCTE Hqtrs, New Delhi. The Appellate Authority accepted the appeal vide order no. F.No. 89-1062/2009-Appeal A 17238 dt. 31.05.2010 and set-aside NRC's order dt. 10.07.09 and remanded the case to NRC for giving another three months time for appointing the faculty as per norms, involving the subject expert nominated by the affiliating body in the selection committee and submit the requisite documents related to faculty selection and appointment, to the NRC, NRC after examining the faculty profile shall decide the case on merit as per regulations. The final decision of the NRC, if it decides to grant recognition would, however, be made operative from the date of withdrawal of the ban on further recognition of ETT course in the State of Punjab imposed by the NCTE and notified vide public notice dated 28.07.2009.

The appeal order and the original file of the Institution, along with all other related documents, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the Northern Regional Committee in its 162nd meeting held from 24th - 27th June, 2010 and the committee directs the institute to submit the list of appointed faculty along with photocopies of all certificates within 30 days. Accordingly, a letter was issued to the institution on 13.07.2010.

The institution submitted its reply on 25.06.2010. Upon consideration of the report submitted by the visiting team, perusal of videography, original file of the Institution, along with all other related documents, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the Northern Regional Committee in its Emergent meeting held on 19th July, 2010 and the committee decided to issue letter under clause 7(11) of the Regulations, 2007.

NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee **hereby grants recognition to Shivalik Hills College of Education, Vill - Patti, Post - Manakpur, Tehsil - Anandpur Sahib, Distt. - Roper, Punjab - 140125 for conducting D.Ed. Course of Elementary**
