ORDER

WHEREAS in terms of Section 15(1) of the NCTE Act, **Lala Jagat Narayan Education College, Vill - Chak Arian Wala, Post - Jalalabad (W), Distt. - Ferozpur, Punjab**, has submitted an application to the Northern Regional Committee of NCTE for grant of permission for starting **M.Ed. Course of one years** duration with an annual intake of **25 (Twenty Five only)** students on **31.10.2008**.

AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Northern Regional Committee in its 146th meeting held on 05th - 07th August 2009 decided to refuse recognition for M.Ed. course. Accordingly, order was issued to the institution on 13.08.2009.

The institution preferred an appeal to the NCTE Hqtrs, New Delhi. The Appellate Authority accepted the appeal vide order no. F.No. 89-887/2009-Appeal dt. 08.10.2009 and NRC order dt. 13.08.2009 was set aside and the case remand back to the NRC for deciding the case on merit after considering the institution reply dated 04.09.2009.

The appeal order and the original file of the Institution, along with all other related documents, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the Northern Regional Committee in its Emergent meeting held on 19th July, 2010 and the committee decided to issue letter under clause 7(11) of the Regulations, 2007.

NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee **hereby grants permission to Lala Jagat Narayan Education College, Vill - Chak Arian Wala, Post - Jalalabad (W), Distt. - Ferozpur, Punjab for conducting M.Ed. Course of Post Graduate (level) of one year duration with an annual intake of 25 (Twenty Five Only) students from the academic session 2010-2011** under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007.

- I. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10.12.2007.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered

8. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

9. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.

10. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

11. In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
