WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- AND WHEREAS, the recognition was granted by NRC to Govt. Post Graduate College, Jaiharikhal, æ2. Pauri Garhwal, Uttarakhand for B.Ed. Course vide order No.F.NRC/NCTE/UR-141/200867169-75 dated 236:12:2008 with an annual intake of 100 seats form the academic session 2008-09.
- AND WHEREAS, the institution Govt. Post Graduate College, Jaiharikhal, Pauri Garhwal, Uttarakhand has by affidavit consented to come under New Regulations and has sought for one basic unit in B.Ed.
- Now therefore, in terms of Section 14(3) (a) of NCTE Act and in accordance with the Regulations, 2014, 4. the Northern Regional Committee, NCTE hereby grants recognition to Govt. Post Graduate College, Jaiharikhal, Pauri Garhwal, Uttarakhand for conducting B.Ed. programme of two years duration with an annual intake of 50 for one basic units of 50 students from the academic session 2015-2016.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by 5. other regulatory bodies like UGC, affiliating University/ Body, State Government etc. as applicable.  - Name of the faculty and staff in full as mentioned in school certificate along with their (b) qualifications, scale of pay and photograph.
 - Name of faculty members who left of joined during the last quarter. (c)
 - Names of students admitted during the current session along with qualification, Percentage of (d) marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - Fee charged from students. (e)
 - Available infrastructural facilities. (f)
 - Facilities added during the last quarter. (g)
 - Number of books in the library, journals subscribed to and additions, if any, in the last quarter. (h)
 - The affidavit with enclosure submitted along with application. (i)
 - The institution shall be free to post additional relevant information, if is so desires. (j)
 - Any false or incomplete information on website shall render the institution liable for withdrawal (k) of recognition.
