## PUBLIC NOTICE

The National Council for Teacher Education (NCTE) invites applications for recognition of teacher training programmes for the academic session 2016-17, except the States and UT(s), with listed programmes, as indicated in para 2 below. The applications in the prescribed form should be submitted "ONLINE" to the concerned Regional Committee along with fee and requisite documents as prescribed in NCTE (Recognition, Norms & Procedure) Regulations, 2014 from I-1 March, 2015 to 31<sup>st</sup> May, 2015 only.

2. The NCTE with a view to achieve planned and coordinated development of teacher education system and in order to regulate the growth of teacher education at all levels, has decided, on the basis of state-wise study conducted on 'Demand and Supply' of teachers and also in consultation with the State Govts. / UTs, not to accept applications for recognition of teacher training institutions/programmes including additional intake / increase in seats in the existing recognized programmes, additional programmes for the academic session 2016-17 in the following States / UT(s) for the programme(s) specified against each:
