Thereafter, the icons for filling the details on NPST and NMM will be activated. You may fill your inputs on NPST and/or NMM. Please keep updating the filled data to avoid any data loss while refreshing of the portal.

The inputs may finally be submitted for consideration. No input may be changed or revised after final submission.
