Public Notice

As per the decision of the NRC, in 335th Meeting held on 15-16 April, 2021, the NRC considered the matter regarding disclosing/updating the information by Teacher Education Institutions of mandatory requirement on their website.

2. The NRC noted that the powers are vested to NRC under clause **7(14)**, **8(6)**, **10(3)** of the NCTE Regulations 2014 and clause **2(c)** of the NCTE Regulations April 2017, which states as under:

7(14)(i) All the applicant institutions shall launch their own website with hyperlink to the Council and corresponding Regional Office websites soon after the receipt of the letter of intent from the Regional Committee, covering, inter alia, details of the institution, its location, name of the programme applied for with intake; availability of physical infrastructure, such as land, building office, classrooms, and other facilities or amenities; instructional facilities such as laboratory and the particulars of their proposed teaching faculty and non teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made on the website namely:

- (a) Sanctioned programmes along with annual intake in the institutions,
- (b) Name of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
- (c) Name of faculty members who left or joined during the last quarter;
- (d) Names of the students admitted during the current session along with qualification, percentage of marks in qualifying examination and in the entrance test, if any, date of admission and such other information:
- (e) Fee charged from the students;
- (f) Available infrastructural facilities
- (g) Facilities added during the last quarter
- (h) Number of books in the library, referred journals subscribed to and additions if any in the last quarter.
- (i) The institution shall be free to post additional relevant information, if it so desires.
- (j) Any false or incomplete information on its website shall render the institution liable for withdrawal of recognition.

8(6): The copy of the affidavit shall be displayed by the institution on its official website. In case, the contents of the affidavit are found to be incorrect or false, the society or trust or the institution concerned shall be liable for civil and criminal action under the relevant provision of the Indian Penal Code and other relevant laws and shall also be liable for withdrawal of recognition by the Regional Committee concerned.

10 (3): Every institution shall display on its official website, every financial year by the 30th day of September, the following statement of account, duly certified by the Chartered Accountant: -

- (i) Balance Sheet as on the last date of the financial year
- (ii) Income and expenditure account for the financial year
- (iii) Receipt and payment account for the financial year
- 2(c): For sub regulation (14), the following shall be substituted namely-
 - "(14) The institution shall adhere to the mandatory disclosures in the prescribed format and display up to date information on its official website and on line monitoring of the institution shall be done through the website of such Institution by National Council for Teacher Education or an agency authorized by it and the amount payable for this purpose shall be determined by the National Council for Teacher Education from time to time."
- 3. In view of the power vested with NRC under clause 7(14), 8(6) of the NCTE Regulations 2014 and clause 2(c) of the NCTE Regulations April 2017, the NRC decided that a notification be uploaded on the website of NRC, NCTE directing to all TEI to disclose/update the information of mandatory requirement on their official website within a month from the date of public notice.
- 4. The NRC has decided that in case the institution (s) has already uploaded the mandatory disclosure as per NCTE Regulations, hard copy of the same, mentioning hyperlink be submitted to this office within 30 days from such notice
- 5, Accordingly, as per the decision of NRC, all the recognized institution are directed to upload the mandatory disclosure on their official website mentioning the above mentioned documentary evidence.
- 6. The above information should be complied within thirty days from the date of public notice as per clause 2 (c) of the NCTE Regulations April 2017.
