- 5. The institution has not submitted Form 'A' from the Bank regarding Endowment and Reserve Fund..
 6. The document submitted in support of Fire Safety Certificate makes a mention of Plot Area as 3162 sqm and whereas the Building plan submitted makes a mention of land area as 4591.07 sqm. The Old Fire Safety Certificate makes a mention of plot area as 40591 sqm. The institution is required to clarify the same.
- 7. The institution has submitted Building Safety Certificate issued by Assistant Engineer, PHED Department, Govt of Bihar on the letter head of Srijan Arch Engineers Pvt Ltd, Patna (Private Engineers).
