ERC is in receipt a letter No.NCTE-CDN016(13)/18/2018-CDN-HQ dated 02.08.2018 from NCTE HQ with a direction to the Eastern Regional Committee(NCTE) to issue Show Cause Notice to the institutions which have been recognized without NET qualified teachers. The institution has to comply with the Show Cause Notice within stipulated period failing to which the Regional Committee may take appropriate action for withdrawal of recognition.

Accordingly, ERC has placed all the TEIs granted recognition after amendment of Regulation-2014 dated 09.06.2017 in 274th Meeting held on 15th-16th July 2019, the committee decided to issue Show Cause Notice to all 97 TEIs for not adhering to a Gazette Notification No.237 dated 09.06.2017. However, no show cause notice has been issued. Subsequently, the same has been placed in 277th ERC meeting held on 19th-20th December, 2019 and the committee decided to re-examine individual files meticulously & may place it in the forthcoming ERC meeting.

Hence, the committee decided to issue show cause notice u/s 14/15/17 of Regulation-2014 to the institutions as listed below with a direction to submit the following within 60 days of the date of issuance of the show cause notice:

- (i) The list of teaching faculty approved by the affiliating body/university at the time of granting recognition by ERC after the issuance of LOI u/c 7(13) of Regulation-2014.
- (ii) Latest teaching faculty list approved by the affiliating body/University duly signed by the competent authority along with affidavit, testimonials, service certificate, marks card etc.

Note: It is pertinent to mention that, those institutions which have submitted the reply based on the minutes of 274th uploaded in the ERC (NCTE) website which shall not be treated as valid reply against non-issuance of the show cause notice to the following Teacher Education Institutions.



It has come to the notice of ERC-NCTE that, many of the recognized Teacher Education Institutions (TEIs) functioning within the jurisdiction of ERC has been granted recognition other courses like Pharmacy, Nursing and other Paramedical courses in the same premises/campus, where Teacher Education Courses granted the recognized by ERC-NCTE. Eastern Regional Committee took a serious view on the same including various complaints issued by the Registrar of various affiliating university mentioning the irregularity of the TEIs. Hence the committee decided the following; -
 - 1. A letter to be sent to the Registrar of all affiliating university within the jurisdiction of ERC-NCTE with a request to furnish the annual affiliating report/inspection report to ERC for necessary examination as deemed fit.
 - Recognized Teacher Education Institution (TEIs) is directed to submit an
 affidavit within 60 days declaring that No. of other courses running in the same
 premises where Teacher Education Programme is being offered and also furnish
 the demarcated area exclusively dedicated for Teacher Education courses to be
 Specified.
 - 3. Any deviation by the TEIs shall viewed seriously and action shall be initiated under section 17 of NCTE Act-1993.
