During the scrutiny of all the new applications, the ERC forwarded the NOC of B.A.B.Sc.B.Ed programme (ERCAPP2467) to the issuing authority i.e. Registrar of Vidyasagar University, West Bengal for verification of its authentication or genuineness. The Vidyasagar University vide letter dated 22.01.2016 reported that the NOC is forged and they have lodged a FIR against the management of the society. Consequently, upon receipt of SCN issued from ERC they have withdrawn all four applications.
