That a writ Petition bearing CWJC No. 9230 of 2016 was filed by Dr. B.R. Ambedkar College of Education, Bodh Gaya & Ors Vs State of Bihar & Ors before the Hon'ble High Court of Patna for the following relief:

- a. For an issuance of appropriate writ in the nature of Mandamus commanding the Respondent State to produce the said notification by which decision has been taken to inspect all the 228 Private Teacher Training Colleges including the Petitioners as referred in Report published in the Daily News Paper dated 12<sup>th</sup> & 13<sup>th</sup> of June, 2016 and after production of the same, a writ in the nature of certiorari be issued quashing the aforesaid decision contained in the said Notification.
- b. For issuance of appropriate writ holding and declaring the exercise of the Respondent State with regard to inspection of the institution by the team constituting of the concerned District Magistrate, Senior Superintendent of Police and the Vice Chancellor of the University to be wholly in teeth of the provisions of the Central Act i.e. NCTE Act, 1993 and the Regulation as framed from time to time.

That the Hon'ble High Court of Patna heard the matter on 21.06.2016 and directed inter alia '*Till further* orders no inspection of any of the institutions will be carried out by the District Magistrate or the Superintendent of Police on the basis of the communication issued at the level of the Chief Secretary'.

That a Counter Affidavit on behalf of National Council for Teacher Education has been filed before the Hon'ble High Court of Patna regarding provision of law as envisaged in NCTE Act, 1993 with respect to conduct of inspection vide letter dated 25.06.2016.

That the matter was lastly heard on 01.09.2016 wherein the Hon'ble Court has directed as follows:

"Learned Counsel for National Council for Teacher Education (Eastern Region) is now, directed to file a clear and categorical affidavit on the issue of inspection from the position indicated and offered by the State, by the next date.

The Court would like to place on record that there has to be an inspection of each and every institution in the background of the controversy with regard to such institutions emerging in the State of Bihar and there is no sighing away from the fact of inspection as part of exercise to identify sub-standard institutions or institutions which have not really complied with the requirements despite provisional permission having been granted by the National Council for Teacher Education (Eastern Region) earlier.

The matter will be listed on 19<sup>th</sup> September, 2016'.

That in the meanwhile, State of Bihar has filed a supplementary Counter affidavit inter alia copy to ERC NCTE received by this office on 10.09.2016.

In view the above, the committee decided as under: The matter be forwarded to the NCTE Hqrs. for further instruction/direction in this case.

The committee is of the opinion that application bearing code No.ERCAPP2701 of the institution regarding recognition for B.Ed. Programme is refused under section 14(3)(b) of NCTE Act 1993.






