Shri Anil Bedge, Prof. Freny Tarapore, Shri Chandrashekhar Vazalwar, Members, WRC; Dr. T.S. Joshi, Dr. Govind Nandede, Shri M.S. The minutes of the 242nd meeting are amended to the extent – in case APP3019, the words from 'now...15/07/2015' are replaced as follows – 'the hardcopy in this case, was received even after 15th July which is the extended date for receipt of hard copy. Hence, the application is summarily rejected'. In APP3370 and APP3385 Times College, the following words are to be added to para 1, line 3 'at a different place'. In APP2754, the line "Hence, Recognition is refused" should be read as "The applicant has not submitted any of the above mentioned documents except the FDRs and the reply of the applicant is not satisfactory. Hence, Recognition is refused on the above grounds."
