

**MINUTES OF THE 247<sup>th</sup> MEETING  
OF**

Smt. Mala Srivastava, Chairperson; Shri L.S. Baghel, Prof. Freny Tarapore, Members, WRC; Shri C.N. Subramaniam, Council Nominee expressed their inability to attend the meeting. The Representatives of States/UTs of Daman & Diu and Dadra & Nagar Haveli could not attend the meeting.

At the outset, Shri Satish Gupta, Regional Director and Convener, welcomed the Chairperson and all the members of WRC, NCTE to the 247<sup>th</sup> meeting of the WRC.

The Regional Director, being Convener of the WRC, presented each agenda item for consideration of the WRC.

The agenda were taken up as follows:-

**247.1 Confirmation of the minutes of 246<sup>th</sup> Meeting of WRC**

The minutes of 246<sup>th</sup> meeting are confirmed except for the following amendments:

- At Serial Nos. 106(APP3165), 107(APP3053) and 108(APP3052), the Recognition should be read as "from the session 2016-2017" instead of 2017-2018. This change has reference to the Order dt. 28/03/2016 passed by the Hon'ble Supreme Court, extending the date to 2<sup>nd</sup> May, 2016, for grant of Recognition for the Academic Session 2016-2017.
- At Serial No. 15(APP3340), the LOI is issued for one unit and not two units.

**247.2 Action Taken Report of 246<sup>th</sup> Meeting of WRC**

The Action Taken Report of the 246<sup>th</sup> Meeting was placed before the Committee.

**247.3 Policy Decisions / letters received from NCTE Hqrs./State Govts.**

The email dt. 30/03/2016 received from the NCTE Hqrs. informing that the Govt. of India has fixed a target before the NCTE to grant recognition to at least 200 institutions for integrated courses, was placed by the RD, WRC before the Committee. The RD, WRC also placed D.O. No.84-4/2016/NCTE/Acad. dt. 05/04/2016 received from the MS, NCTE directing to bring the contents of this letter and other clarification letter to the notice of the Chairperson and members of the respective

Regional Committees for according priority to the applications of the four year's B.Sc./B.A.B.Ed. integrated programs.

In order to expedite the processing and grant of Recognition for integrated courses, the Committee decided to authorize the RD, WRC to constitute VTs in cases of integrated programs where Show Cause Notice was issued and the institution submitted reply to the Show Cause Notice complying to the requirements laid down in the NCTE Regulations, 2014 and the Norms for the integrated course. As soon as the VTR is received, the case may be placed before the WRC.

The cases from the banned districts for D.El.Ed. course with/without NOC of the affiliating body, have been considered by the WRC in the light of the order of the Apex Court in SLP (C) No. 5102/2016 and SLP (C) No.7461/2016. The SLPs are sub-judice. The cases shall be decided finally in the light of the order to be passed by the Apex Court.
