





259.4.5 Consideration of replies received in response to Show Cause Notice (Collector's report)

The WRC examined the records received from the Madhyamik Shiksha Mandal, Collector Gwalior, Lokaayukt Madhya Pradesh, regarding the 39 cases where complaints were received by the State Government. Since there were some internal inconsistencies, the WRC directed the regional office to examine and reconcile all the lists and prepare a final list of 39 cases under 4 categories. The first category will consist of institutions which have building and staff, the second will be of institutions having building and part staff, the third will consist of institutions which have building but no staff and the last category will be of institutions having no building and no staff. This data may be put up in the next meeting of the WRC.

Out of these 39 institutions, recognition for two of institutions had already been withdrawn earlier (Code Nos. 222144 – Shri Ramnath Singh Shiksha Mahavidyalaya & 222310 - Rishikul Group of D.Ed. College) and in this meeting the recognition of two more institutions (Code Nos. 222288 - Indian International College of Education and 222431 - Kailadevi College of Education) has been withdrawn.

Any Other Item

Guidelines to WRO regarding disposal of new applications for the session 2017-2018:

- All cases where recommendations have been received from the State Govt. should be scrutinized immediately and Show Cause Notice, wherever required, should be sent by the WRO without referring to WRC.
- ii) All applications where State Govt.'s recommendations have not been received, reminder should be sent and after 90 days, the cases should be scrutinized and Show Cause Notice, wherever required, should be sent by the WRO without referring to WRC.
- iii) It should be ensured that in all matured cases VT should be constituted by the WRC.
- iv) All VTs should be completed by end of January 2017.

- v) All LOIs should be issued by the beginning of February 2017, so that cases are disposed of before 3^{rd} March, 2017.
- vi) All the existing cases should also be disposed of as early as possible, so that decision in most of the cases would be taken by end of November, 2016.

Issue of Revised Orders:

- The RD should issue revised orders as soon as the Affidavit and compliance with the NCTE Regulations, 2014 is received. If compliance report is not received, revised intake would be restricted.
- ii) All institutions which have not submitted the Affidavic and the compliance report would be issued Show Cause Notice under Section 17, as to why the Recognition should not be withdrawn.
- iii) Institutions which have requested for reducing intake may be permitted.
- iv) Action should be completed within one month.
