As decided in 214th ERC meeting, permission to M.Ed. Course was refused vide order No.46798 dated 25.05.2016. The institution preferred CWJC No.18757 of 2018 in the Hon'ble High Court of Patna. The Hon'ble High Court disposed of the matter on 18.09.2018 with a direction inter alia:

"So far as the submissions made on behalf of the petitioner that his application for grant of recognition should be reconsidered by the N.C.T.E, after grant of 'No Objection Certificate' by the University, I am of the view that such direction, cannot be issued. The petitioner had filed his application for recognition, which was rejected by the N.C.T.E. for the reason mentioned therein. His application for recognition thus came to be disposed of. If the college has been granted 'No Objection Certificate' subsequently in the year 2018, it will be open to the petitioner to apply afresh before the N.C.T.E for grant of recognition/permission, in accordance with law."

The Committee considered the order of the Hon'ble High Court of Calcutta and decided as under:

The application of the institution be entertained afresh during the time of fresh advertisement with No Objection Certificate of 2018. A letter be issued to the institution stating the above position.

As per decision of 246th ERC meeting, recognition to B.Ed. course was refused vide order dated 08.12.2017. The circular of ERC, NCTE vide No.F.4-19/NCTE/ERC/Accounts/2018/58333 dated 13.11.2018 which has made it mandatory for officials to travel by Air-India flights, along with imposition of other conditions was placed before the Eastern Regional Committee. The members, on perusal of this circular, expressed grievance on the following grounds:-

- (1) Most of the Eastern and North Eastern States (Members of ERC) do not have direct Air-India flight to Bhubaneswar. So the members have to adopt different combination of flight schedules. Most of these combinations do not cover Air-India timings.
- (2) Depending on available flight schedules of Air-India, the members, if they have to travel by Air-India only, may have to spend another 2 to 3 days prior/later in addition to actual meeting days. This would severely hamper regular official duties of these members and they may not be in a position to attend ERC meetings. Further, it is apprehended that there may not be required quorum in the ERC meeting to take decisions on crucial matters.

In view of the above propositions, special relaxation may be provided to the ERC members belonging to the Eastern and North Eastern States on this aspect.

Further, the members requested to review the earlier decision and issue necessary instruction permitting such members to travel by airlines other than Air-India.
