At the outset, the Regional Director welcomed all the members of Committee and apprised them about the provisions of the NCTE Act, Rules, Regulations and Guidelines issued from time to time. With the permission of Chairperson, Mr. Pradeep Kumar Yadav (Convener) presented the Agenda before the Committee for its due consideration and appropriate decision.

ATTENTION!

- 1. The Committee unanimously decided that the institution may reply in response to the decision of the Committee uploaded on the ERC website without waiting for formal letters from the office of ERC. The replies so received will also be considered by the Committee. The institutions are requested to submit the softcopy (scanned PDF documents) by the schedule time followed by the hardcopy.
- 2. The Endowment Fund/Reserve Fund (5 Lakhs+7 Lakhs) amounting to Rs.12 Lakhs per programme. (See ERC website: www.ercncte.org for detail).
- 3. The institution needs to submit list of 10 schools preferably MoUs for internship and school based activities duly approved by District Education Officer.
- 4. Institutions must give the affidavit for consent / willingness for number of units either one or two, if it was not submitted earlier.
- 5. As per provisions u/s 17(4) of the NCTE Act, 1993, if an institution offers any course or training in Teacher Education without obtaining recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.
- 6. The Committee suggested to prepare Data Bank for the teachers.
- 7. The institution needs to instal Fire Safety equipment and submit the Fire Safety Certificate from the appropriate authority, if not submitted earlier.

- (ii) Approved building plan by the concerned competent Govt. Engineer/Authority.
- (iii) Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- (iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- (v) Confirmation on website updates of the institutions with all details along with affidavit.

In view of the above, the Committee decided as under:

Final Show Cause Notice under section 17(1) of NCTE Act, 1993 be issued to the institution for compliance in the form of soft copy (scanned PDF documents) through email: revisedordercomplianceerc2015@gmail.com within 21 days of uploading of proceedings on ERC website followed by hard copy of the same by hand/speed post/courier, failing which withdrawal of recognition will be taken up by ERC as per NCTE Act, Rules & Regulations.

The institution preferred W.P. No.8999 (w) of 2019 in the Hon'ble High Court of Calcutta. The Hon'ble High Court passed an interim order as mentioned below:

"Accordingly, after being prima facie satisfied, I restrain the NCTE from giving any effect and/or further effect to the impugned letter dated 12th April, 2019 till 21st June, 2019. The petitioner-institution

is at liberty to apply for affiliation of B.Ed. course (New and Renewal) for the session 2019-2020. If the petitioner-institution applies for affiliation, the respondent No. 3 is directed to accept the same upon compliance of all formalities".

The Committee considered the order of the Hon'ble High Court of Calcutta as well as NCTE Hqrs. letter dated 16.05.2019 and decided as under:

The NCTE Hqrs. has instructed vide letter dated 16.05.2019 that the Standing Counsel is to prepare and file counter affidavit. Also the institution has not submitted any application after the Court order till date. Hence, there is no action at the moment on the part of ERC, NCTE.

As decided in 209th ERC Meeting, permission to D.El.Ed.(ODL Mode) Course was refused vide order dated 13.04.2016. The institution preferred an appeal to NCTE HQs. against the refusal order and the Appellate Authority vide order No89-299/2016 Appeal/9th Meeting-2016/35653 dated 04.08.2016 rejected the appeal and the order of the ERC is confirmed.

The institution preferred W.P.(C) No.3813 of 2019 & CM No.17396/2019 in the Hon'ble High Court of Delhi. The Hon'ble High Court disposed of the matter on 12.04.2019 with a direction inter alia:

"The ERC is directed to process the application of the petitioner within six weeks. Needless to say, the present order has been passed without prejudice to the rights and contentions of both the parties. In case, the petitioners are still aggrieved by any order passed by the respondents, they make take legal recourse as permissible under law".

The Committee considered the order of the Hon'ble High Court of Delhi and observed as under:

(i) NOC from Distance Education Bureau (DEB) of UGC not submitted.

In view the above, the Committee decided as under:

Show Cause Notice be issued to the institution as to why the application applied for permission be not refused on the above point. The Committee therefore, provides last opportunity under section 15(3)(b) of the NCTE Act 1993 to the institution to submit its reply within 21 days from the issue of this letter before the Committee takes final decision.

Teacher Education Institutions in the State of Bihar affiliated to different Universities received through NCTE HQrs. vide letter No.NCTE-Reg.1011/11/2019-US(Regulation)-HQ/78664 dated 16.05.2019 for necessary action as per NCTE Act/Regulations by placing the matter before the ERC as these institutions have failed to upload photographs of faculty and students by means of which created suspicion about their conduct and quality of teachers.

In view of the above, the Committee decided as under:

Show Cause Notice u/s 17(1) be issued to the above 16 recognised institutions under different Universities to comply fulfillment of conditions mentioned under Clause 7(14)(i) of NCTE Regulations, 2014 and display the same on their official website. A compliance report in this regard be submitted within 21 days.
