The online application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

The institution had not uploaded the reply of First Show Cause Notice dated 14.02.2025.

- (i) In the Institution Details section for 'Multidisciplinary Institution', it is shown as 'YES' but the institution has not uploaded latest affiliation letter of these courses issued by affiliating body.
- (ii) Regarding the Institution running NCTE recognized course(s), the institution has uploaded copy of map in the place meant for copy of recognition order.
- (iii) The institution has not uploaded recommendation of State Govt. for the academic session 2025-26.
- (iv) Authorization letter uploaded by the institution but not on the stamp paper.
- (v) The institution has not uploaded land documents. "As per 2014 Regulations "Clause (4)(i) No institution shall be granted recognition under these regulations unless the institution or society sponsoring the institution is in possession of required land on the date of application. The land free from all encumbrances could be either on ownership basis or on lease form Government or Government institutions for a period of not less than thirty years. In cases where under relevant State or Union territory laws the maximum permissible lease period is less than thirty years, the State Government of Union territory administration law shall prevail and in any case no building shall be taken on lease for running any teacher training programme."
- (vi) The institution has uploaded copy of map in the place meant for Land Use Certificate (CLU).
- (vii) The institution has uploaded Mutation Certificate in the place meant for Non-Encumbrance Certificate (NEC).
- (viii) The building plan uploaded by the institution is not approved by the competent Govt. authority. As the institution is offering various courses, it is required to upload Building plan approved by competent Govt. Authority mentioning name of institution, Khasra

no./Plot no., total land area, total floor wise built-up area, and the earmarked built up area for the ITEP program and other courses being run in same premises.

- (ix) The institution has not uploaded Building Safety Certificate from National/State Disaster Management Authority.
- (x) The institution has not uploaded Fire Safety Certificate issued by competent Govt. Authority through online LSG portal of Govt. of Rajasthan.
- (xi) The building completion certificate has not been uploaded by the institution.

Final Show Cause Notice be issued to the institution for compliance of deficiencies through online ITEP application portal.

Decision of WRC:

The online application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time along with reply of Final Show Cause Notice dated 16.01.2025 and the Committee observed as under:

(i) The institution has uploaded the bank statement (Punjab National Bank) of last six months indicating the transaction of the salary / remuneration to its teaching staff. However, the bank statement in respect of teaching staff of B.A. B.Ed./ B.Sc.

B.Ed, B.Ed., D.El.Ed., M.Ed. and Shiksha Shastri (Sanskrit) course is not highlighted by the institution. Hence, the institution is required to upload the bank statement from concerned bank of last six months indicating the transaction of the salary / remuneration to its teaching staff highlighting the B.A. B.Ed./ B.Sc. B.Ed, B.Ed., D.El.Ed., M.Ed. and Shiksha Shastri (Sanskrit) programmes being offered by the institution.

- (ii) The institution has not uploaded Fire Safety Certificate issued by Fire Safety Department, Government of Rajasthan verifiable on the official portal of the Fire Department, Government of Rajasthan at URL https://lsgonline.rajasthan.gov.in/track_application.aspx.
- (iii) The institution has uploaded the BCC in old format. The institution has not uploaded latest Building Completion Certificate in the prescribed format of NCTE (17 points) issued by the Competent Government Authority for all the courses being conducted in the premises.

(iv) The organization has given letter for name change on 30.01.2025. A copy of the letter and private college policy has been enclosed stating the following:
"The institution namely Rajasthan College of Education is running course (B.A. & B.SC.) in the field of liberal arts, humanities, social sciences, commerce or mathematics. As per Point No. 7.6 od private Degree college policy of college education department, Rajasthan in the name of college prohibited words like i.e. (TEACHER TRAINING /T.T. / TECHNICAL /P.G. / POST GRADUATE/ ENGINEERING). So different name Rajasthan College of Education and Rajasthan College of Teacher Training both colleges. Copy of policy of college education department, Rajasthan & Copy of Affiliation enclosed. However, the institute submitted application to the NCTE for the change name of college Rajasthan College of Teacher Training to Rajasthan College of Education."

In view of the above, the application for transition to ITEP is rejected.

Decision of WRC:

The online application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time along with the reply of Final Show Cause Notice dated 16.01.2025 and the Committee observed as under:

- (i) The institution has not uploaded latest Building Completion Certificate in the prescribed format of NCTE (17 points) issued by the Competent Government Authority for all the courses being conducted in the premises.
- (ii) As per the uploaded documents the applicant institution is not conducting any course of Liberal Arts, Humanities, Social Sciences, Commerce or Mathematics as a mandatory requirement to be a Multidisciplinary Institution as per NCTE norms. The institution

namely NIRMAL TEACHER TRAINING COLLEGE is not running any college in the field of liberal arts, humanities, social sciences, commerce or mathematics.

- (iii) The name of the institution "NIRMAL TEACHER TRAINING COLLEGE" mentioned in the application and recognition order of B.A.B.Ed./B.Sc.B.Ed. whereas "NIRMAL MAHAVIDYALAYA" mentioned in the university letter of affiliation with regard to Multi-disciplinary Programmes uploaded by the institution. Both the names are different. Therefore, as per NCTE Regulations, 2014 as amended from time to time, the application of the institution does not fall in the category of Multi-disciplinary institution.
- (iv) The institution has not uploaded Building Plan approved by the Competent Authority of State Government indicating the Khasra/Plot/Survey No. and mentioning the total land and built-up area earmarked for each course being run in the premises and the demarcated land and built-up area for the teacher education programmes including multi-disciplinary programmes.
- (v) The institution has uploaded bank statement indicating the transaction of the salary / remuneration to its teaching staff. However, it cannot be ascertained from the uploaded documents whether the institution is paying salary to its staff as per Central/State Government pay scales in accordance with the norms and standards of NCTE.
- (vi) The website of institution nirmaleducation.org/index.aspx has NOT been updated and maintained in compliance to provisions under Clause 7(14)(i), 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as amended from time to time.
- (vii) The institution has not uploaded Mutation Certificate of land. But as per previous Preliminary Scrutiny uploaded document was Jamabandi at Khasra No. 1452, 1521/1, 1521/2. or Khasra Number 1453 which is not visible.
- (viii) The institution has uploaded Building Safety Certificate issued/approved by Adhishashi Abhiyanta Sa.Ni.Vi. Khand Hindon City dated 29/01/2025 stating that the building is safe for the year 2024-25, but time period has not been mentioned therein.

In view of the above, the application for transition to ITEP is rejected.

Decisio	(Court matter) Decision of WRC:			

The WRC has been informed that the institution had filed Writ Petition before the Hon'ble High Court of Delhi at New Delhi having W.P. (C) No. 3479/2025, the Hon'ble High Court vide Order

dated 03.04.2025 had directed the following:-

"5. In view of the aforesaid submission of the learned counsel for the respondents, this Court finds that since no show cause notice in terms of Section 17 of NCTE Act, 1993 has been given and there is complete noncompliance of the principles of natural justice, the impugned order dated 11.08.2023 is unsustainable in law. Accordingly, the impugned order dated 11.08.2023 is quashed and set aside.

6. Consequently, the order of the learned Appellate Authority dated 19.12.2023 has also been rendered unsustainable and the same is also set aside.

7. Resultantly, the respondent no.2 is directed to issue an order of restoration of recognition of the petitioner's institute for B.Ed course clearly stating that the petitioner's institute is entitled to admit students in B.Ed course for an Academic Session 2025-26 and for all subsequent academic sessions.

8. Further, the respondent no.2 is also directed to reflect the status of the petitioner's institute as a recognised institute on its official website and to intimate the same to its affiliating universities i.e., [Rashtrasant Tukadoji Maharaj Nagpur University, Maharashtra] and to the "Education Secretary, [Higher Education] Govt. of Maharashtra".

The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time along with the direction of the Hon'ble High Court of Delhi at New Delhi in Writ Petition No.3479/2025 & CM APPL. 16277/2025 vide order dated 03.04.2025 and the Committee decided as under:

(1) In compliance of Court order dated 03.04.2025, order of restoration of recognition for B.Ed. course of two years duration be issued to the institution. As stated in the Court Order dated 03.04.2025, the institution is entitled to admit students in B.Ed. course for the academic session 2025-2026 and subsequent academic sessions. Copy of the restoration order be endorsed to concerned State Govt. (Education Secretary, Higher Education, Govt. of Maharashtra), Affiliating Body (Rashtrasant Tukadoji Maharaj Nagpur University, Maharashtra) and all concerned. The name of the institution shall be displayed in the list of recognized institutions on the official website of WRC.

(2) Further, the Committee observed that the compliance of the conditions of the Revised Recognition Order dated 31/05/2015 in consonance with NCTE Regulations 2014 as amended from time to time shall be ascertained from the institution. Therefore, the Committee decided that separate communication in the form of Show Cause Notice u/S 17(1) of NCTE Act, 1993 be issued to the institution with direction to submit following documents supported with an affidavit within 21 days from the date of issue of the letter:

- (i) The institution is required to submit Certified Registered Land Documents issued by the Registering Authority.
- (ii) The institution is required to submit certified copy Mutation certificate of Land issued by competent Govt. authority.
- (iii) The institution is required to submit Blue Print of approved Building Plan signed by the Competent Govt. Authority indicating the name of the courses, name of the institution, Khasra No./Plot No., total land area, total built-up area with the measurements of the Multi-purpose Hall as well other infrastructural facilities such

as class rooms etc. and earmarked land and built up area for each course being run in same premises.

- (iv) The institution is required to submit Change of Land Use Certificate issued by the Competent Government Authority to use the land for educational purpose.
- (v) The institution is required to submit latest Non-Encumbrance Certificate issued by the Competent Government Authority indicating that the land is free from all encumbrances.
- (vi) The institution is required to submit certified copy of Site Plan with demarcated land area for running different courses in the premises.
- (vii) The institution is required to submit Building Safety Certificate issued by the Competent Government Authority.
- (viii) The institution is required to submit Fire Safety Certificate issued by the Competent Government Authority.
- (ix) The institution is required to submit Certificate to the effect that the building is differently abled friendly issued by the Competent Government Authority.
- (x) The institution is required to submit Building Completion Certificate in prescribed format signed by the Competent Government Authority containing 17 points, which is available in WRC web portal.
- (xi) The institution is required to submit latest approved appointed faculty/ies list for B.Ed. programme countersigned by the Registrar of the concerned university in the prescribed format available at WRC web portal as per provision of Clause-5 of Appendix-4 of NCTE Regulations, 2014 as well as point No. 8 of GOI No. 237 dtd. 09.06.2017.
- (xii) The institution is required to submit photocopies of valid Fixed Deposit Receipts issued by Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint operation mode with Regional Director, WRC, NCTE & Management along with duly filled Bank Form "A" in original, verified/signed by the Manager of the Bank as per NCTE Regulations, 2014.

The institution is required to submit information of downloaded copies of documents from the website of the institution with hyperlinks of the same as per provisions under Clause 7(14)(i) of NCTE Regulations, 2014 as amended from time to time.

Decision of WRC:

The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time along with the direction of the Hon'ble High Court of Delhi at New Delhi in Writ Petition No.3338/2025 vide order dated 18.03.2025 and the Committee observed that the institution is required to submit following documents supported with an affidavit:

(i) Mutation Certificate of land in respect of Khasra No.871,872,874 of land in possession by the institution in its new premises issued by competent authority of

State Government.

- (ii) Change of Land Use Certificate (CLU) in respect of Khasra No.871,872,874 of land in possession by the institution in its new premises issued by competent authority of State Government.
- (iii) Latest Non-encumbrance Certificate in respect of Khasra No.871,872,874 of land in possession by the institution in its new premises issued by competent authority of State Government.
- (iv) Blue print of Approved Building plan showing plot/khasra no., total land area of land, total built up area, earmarked land area and built up area separately for all courses running in the premises issued by competent authority of State Government.
- (v) Site Plan in respect of Khasra No.871,872,874 of land in possession by the institution in its new premises issued by competent authority of State Government showing whether the land pertaining to Khasra No.871,872,874 is in single plot or not.
- (vi) Building Completion Certificate in NCTE prescribed proforma containing 17 points issued by competent authority of State Government.
- (vii) Latest list of Teaching Staff in NCTE prescribed format for all recognized courses countersigned by Registrar of Affiliating Body/University.

In view of the above, Committee decided that the institution be informed to submit reply supported with an affidavit within 21 days from the date of issue of letter.

Decision of WRC:

The representation dated 18.12.2024 of the Secretary of M D Memorial Educational & Social Welfare Trust received in the office WRC, NCTE on 26.12.2024 was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time along with the direction given by the Hon'ble High Court of Delhi at New Delhi in Writ Petition No.2248/2025 vide order dated 10.03.2025 and the Committee observed as under:

- (i) As per records of WRC, there is no pending representation dated 20.12.2024 of the institution as mentioned in the court order dated 10.03.2025 passed by the Hon'ble High Court of Delhi at New Delhi, rather the office of WRC, NCTE received representation dated 18.12.2024 from the Secretary of M D Memorial Educational & Social Welfare Trust on 26.12.2024.
- (ii) There is no pending application/document/records for M.Ed. course in the office of WRC as claimed by the management of institution as on date. There is no such direction given by Hon'ble High Court Judicature for Rajasthan at Jodhpur as claimed by the Secretary of the management i.e.MD Memorial Educational & Social Welfare

Trust to process the application for grant of recognition/permission to M.Ed. course, which is in confirmation of authentic order dated 26.08.2021 in S.B. Civil Writ Petition No.11438/2021 downloaded from official website of Hon'ble High Court Judicature for Rajasthan at Jodhpur.

(iii) The Management of the institution itself has furnished false and fabricated information/document and mis-interpreted the decision of the Council taken in its Minutes of 55th and 59th General Body Meetings (not applicable for this institution). Accordingly, as decided by WRC in its 414th (Part-I) Meeting held on 18th-21st February, 2025, a warning letter dated 17.04.2025 has been communicated to the correspondent of the management/society of the institution.

In view of the above, the Committee took note of its earlier decision taken in 414th (Part-I) WRC Meeting and decided that the same be conveyed to the correspondent of the management/society of the institution.
