Decision of WRC:

- i. The institution has uploaded online copy of Jamabandi of land bearing Khasra No.906/360/2, 356/1, 902/354/1 with total land 8000 sq meters and replied that the institution has uploaded old and new Khasra No. (906/360/2 new Khasra No. 952/906 land 0.16 hectare, old Khasra No. 902/354/1- new Khasra No.949/902 land 0.16 hectare, old Khasra No. 356/1- new Khasra No. 948/356 land 0.33 hectare, old Khasra No.962/356/2- new Khasra No.989/962 land 0.55 hectare, old Khasra No. 962/358/1- new Khasra No. 988/962- 0.20 hectare and 963/356 land 0.09 hectare issued by Patwari, Sikar, Rajasthan dated 18.09.2020 and online Revised Conversion Order Khasra No. 952/906 land 1600 sq. mtr. & 963/356 land 900 sq. mtr. total land 2500 sq. mtr. dated 28.12.2022, online Conversion Order Khasra No. 989/962 land 5500 sq. mtr.). The uploaded file as attachment to reply in the portal is not opening. All Khasra Nos. mentioned as per above submitted by institution found mismatch with khasra nos. as per transition application portal.
- ii. The institution has uploaded Building Plan and showing ground floor, first floor and second floor approved by Sahayak Engineer, PWD Sub- Division, Palsana, Rajasthan but institution has not shown floor wise built up area. The institution is required to upload Building Plan approved by the Competent Authority of State Government indicating the Khasra/Plot/Survey No. mentioning the total land area and total Built-up area earmarked for each course being run in the premises and the demarcated land area and built up area for the teacher education programmes.
- iii. The institution has uploaded photograph of Multipurpose hall. The institution is required to submit geotagged photographs of the Multipurpose Hall at different angles clearly indicating the longitude and latitude with date of photograph.
- iv. The institution has uploaded photograph of Playground. The institution is required to submit geotagged photographs of the Playground at different angles clearly indicating the longitude and latitude with date of photograph.
- v. The institution has uploaded Building Completion Certificate giving details of Khasra bearing No. 952/906, 963/356 and 989/962 approved by Sahayak Engineer, PWD, Sub- Division, Palsana, Sikar, Rajasthan dated 13.01.2025 but not approved by local Govt. authority with date. The Khasra No, shown by the institution in the Building Completion Certificate found mismatch with khasra no. as mentioned in the portal.
- vi. The institution has uploaded photo of building with computerized name showing this name is not found real and not clarified that building pertains to institution or not.
- vii. The institution has uploaded photographs of the Library. However, the institution is required to submit geotagged photographs of the Library at different angles clearly indicating the longitude and latitude with date of photograph.
- viii. The institution has uploaded Non-Encumbrance Certificate Khasra No. 952/906, 963/356, 989/962, 988/962, 949/902 issued by Tehsildar, Dantaramgarh, Sikar, Rajasthan dated

- 25.01.2023 but all Khasra Nos. do not match with Khasra no. as mentioned in the portal by institution.
- ix. The institution has uploaded photograph of Lift. However, the institution is required to submit geotagged photographs of the Lift at different angles clearly indicating the longitude and latitude with date of photograph.
- x. The institution has uploaded self declaration Not-for-Profit Certificate dated 20.02.2024. Institution has not uploaded Not-for-Profit Certificate issued by the Govt. Competent Authority.
- xi. The website of the institution has not been in compliance to Clause 7(14)(i), 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as amended from time to time.
- xii. The institution has uploaded photos showing toilets blocks for both girls & boys students but the same are not found to be adequate. Institution has also not shown wash basin & toilets blocks for persons with disabilities. The institution is required to submit geotagged photographs of the toilet blocks at different angles clearly indicating the longitude and latitude with date of photograph.
- xiii. The institution has uploaded building plan with total built up area 2647sq.mtr. Multipurpose hall shown in the building plan 60*30= 1800 sq. ft. which is less than that specified under NCTE norms. The institution has replied that they have other building available for the Multipurpose hall Programme but same has not been shown by institution. Size of multipurpose hall mentioned in portal as 225.806 sq. mtr. which is mismatch with that mentioned in building plan. The above anomaly establishes the fact that institution does not have adequate infrastructure and instructional facilities as per norms and standards.
- xiv. Institution has uploaded self declaration for the institution with regard to Building Safety Certificate. As per NCTE ITEP Regulations 2014 that "The institution shall adhere to safety guidelines as prescribed by National Disaster Management Authority(NDMA)", the institution has not uploaded Building Safety Certificate issued by competent authority of State Govt.
- xv. The institution has not uploaded the photos of Ramps, handrail and Lifts for accessibility to the persons with disability as per norms and standards. The institution is required to submit geotagged photographs at different angles clearly indicating the longitude and latitude with date of photograph.
- xvi. The institution has uploaded certificate issued by Chartered Accountants dated 24.01.2025 and reply that "this is to certify that M/s Ashwini Shikshan Sansthan, Bay, Dantaramgarh, Sikar, Rajasthan having, Pan Number AADAA9251H is a society constituted for advance of education. The society is having annual receipts below 5.00 crores, hence it need not to obtain registration u/s 10(23) (iiiad) of the income Tax Act, 1961. The institution is required to upload Exemption Certificate (12A) / Form 10AC (order for registration) under Income Tax Act, 1961.
- xvii. The institution is required to upload Fire Safety Certificate issued by Fire Safety Department, Government of Rajasthan verifiable on the official portal of the Fire Department, Government of Rajasthan at URL https://lsgonline.rajasthan.gov.in/track application.aspx

One common hand washing station, with four taps, in an open area shall be provided."

The institution has not submitted the information in the form of Affidavit as per National Council for Teacher Education (Recognition Norms and Procedure) Amendment Regulations, 2022, In the Principal regulations, in regulations 8 for sub-regulation (5), "(5) The institution or society shall upload an affidavit on Rupees one hundred stamp paper duly attested, by the Oath Commissioner or Notary Public stating the precise location of the land including khasra number, village, district, state, the total area in possession and the permission of the competent authority to use the land for educational purposes and mode of possession. In case of Government institutions, the affidavit shall be furnished by the authorised signatory. The affidavit shall be accompanied with

the certified copy of land ownership or lease documents with the registering authority and the permission of the competent authority to use the land for educational purposes including approved building plan as per provision contained in sub regulation (4) of regulation 5."
