The institution has submitted copy of Land transfer deed dated 23.06.1953 between Governor of Bombay (Guarantor) and Maharashtra Education Society (Society) of land survey no. 160A of measuring 23 acres and 30 gunthas. Further, the Committee noted that the institution had submitted an affidavit dated 12.04.2006 sworn by Shri Latif Makhdoom, Secretary of Maharashtra Cosmopolitan Education mentioning as under:

It is pertinent to note that only one institution viz. Maharashtra Cosmopolitan Education Society, **S.No. 160A, Haveli, Pune, Maharashtra** is being run on the address mentioned in the lease deed submitted by the institution whereas the remaining three institutions are running at the address: **2390, K.B. Hidayatullah Road, Azam Campus, Pune Camp, Pune-411001, Maharashtra.**

The institution shall clarify the different versions in respect of the land in affidavit and land documents. Further, the institution shall provide certified registered Land documents with address and location related to conduct of different teacher education courses (present and proposed).

In view of the above, the Committee decided that the institution be sought aforementioned clarifications to submit reply along with requisite documents and affidavit within 21 days from the date of issuance of letter.

The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed that the institution is still deficient on the following with regard to its shifting application:

1. The University is required to submit proof / evidence to prove that it is a Multi-disciplinary institution as per clause 2(b) of NCTE Regulations, 2014.
2. The University is required to submit Certified registered land documents issued by the Registering Authority
3. The University is required to submit Blue print of approved Building plan signed by the Competent Govt. The Committee noted that ample opportunities have been provided vide WRC Show Cause Notice dated 07.07.2023, Final Show Cause Notice dated 12.04.2024 to the institution for providing the requisite documents as per the NCTE Regulations, Norms and Standards However, the institution has not complied the deficiencies as detailed below:

Land) Act, 1971 the institution has not enclosed agreement copy of land.
- c) The institution has submitted Possession Receipt executed by the Government of Maharashtra Revenue Department through Tahasildar Nagpur (Rural).
- d) The Verification and search report cum Non-Encumbrance Certificate dated 16.03.2017 issued by Deepak. Kamble (Advocate) is not issued by competent authority of State Govt.
- e) Building plan of the institution is not readable and the same is not approved by competent authority of State Govt.
