### Decision of WRC:

The online application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee decides as under:

#### **Court matter of Tagore, TT College, Bhadoli Road, Bonli, Rajasthan in respect of B.A.B.Ed/B.Sc.B.Ed. Course**

The matter was considered by the WRC in its 412<sup>th</sup> meeting held on 13<sup>th</sup> January 2025 wherein the Committee decided as under:

The original file of the institution alongwith other related documents NCTE Act 1993, Regulations and Guidelines of NCTE notified from time to time were carefully considered by WRC and following observation was made:

The Hon'ble High Court of Rajasthan at Jaipur bench in S.B. CIVIL WRIT PETITION No. 16082/201 vide its order dated **04.02.2022** decided the following:

***“On consideration upon the submissions advanced by both the sides, this Court is of the view that the impugned orders dated 08.02.2018 and 16.04.2019 are required to be set aside, as the same were passed in violation of principles of natural justice and further directions are issued for consideration of the application of the respondents for recognition in the integrated course for the successive years in question as per the merits of their case and in accordance with law within a period of 45 days.”***

2. Thereafter, petitioner filed the contempt petition S.B. civil contempt petition no. 635/2022 in which he prayed before the Hon'ble High Court of Rajasthan at Jaipur bench for compliance of the order dated 04.02.2022 which is listed for hearing on 15<sup>th</sup> January 2025.

3. The WRC noted the facts of the matter as under:

- i. That earlier this matter was decided by NRC in its 280<sup>th</sup> meeting held on 6<sup>th</sup> to 7<sup>th</sup> February 2018 by rejecting the application vide NRC Refusal Order dated 08.02.2018 which was subsequently confirmed by the Appeal Committee while disposing the appeal filed by the petitioner institution vide Appeal Order dated 16.04.2019.
- ii. Further, NCTE vide notification dated 22.10.2021 omitted the B.A.B.Ed/B.Sc.B.Ed. Course (Appendix 13 of the NCTE Regulations 2014) from the list of approved pre-service teacher education programmes.
- iii. The Council in 54<sup>th</sup> General Body (GB) meeting held on 27.04.2022 decided that all the applications pending before the regional committees for B.A.B.Ed/B.Sc.B.Ed. Course shall not be processed further.
- iv. Thereafter, the Council in its 55<sup>th</sup> GB meeting held on 14th July 2022, has decided to return all those applications which are not in line with NEP 2020 irrespective of any course.
- v. In compliance to the above policy decision of GB the WRC in its 392<sup>nd</sup> meeting held on 22<sup>nd</sup> August 2023 has decided as under:-

*“In light of decision taken by the Council in its 55<sup>th</sup> General Body meeting held on 14.07.2022, WRC considered the matter in detail and decides that all the applications pending at any stage be returned to the institutions.”*

4. Accordingly, in keeping the above position in view it is evident that the application of the petitioner institution was not a pending application on 04/02/2022 (Date of the Court Order). The institution has exercised the available remedy under section 18 of the NCTE Act, 1993 by filing appeal against the decision of the WRC which has been rejected by the Appeal Committee while confirming the order of NRC. Further, the Norms & Standards for B.A B.Ed. or B.Sc. B.Ed. course Appendix-13 has already been omitted as per the policy decision of the GB. Therefore, the application of the petitioner which was already been disposed cannot be treated as pending as on date on the part of WRC. Therefore, the WRC cannot consider the application of the petitioner at this stage. However, the petitioner may apply afresh as and when the applications are invited by the NCTE.
