Name of the institution mentioned in the uploaded recognition order for B.Ed. programme does not match with the name of the institution mentioned on applied application on portal and also differ with the name mentioned in the recognition order for B.A.B.Ed./B.Sc.B.Ed. Programme issued by NCTE.
- ii. Details of authorization person/representative does not match with uploaded documents which is also on the letter head of Sabarmati University (Formerly CALORX TEACHERS' UNIVERSITY) A State Private University Estabalished by State Legislature of Gujarat Act No. 8 of 2009 & further amended with Act No. 20 of 2019) (A dual mode University : Regular / Distance) and the institution namely CALORX INSTITUTE OF EDUCATION merged with Sabarmati University without the approval of WRC, NCTE.
- iii. Uploaded Copy of Not-for-Profit Certificate is not issued by the Competent Govt. Authority. Copy of registration certificate of the Trust/Society is not uploaded. Uploaded Byelaws of the Trust/Society/Company is not registered with the Registrar of the concerned jurisdiction. Exemption Certificate (12A) is not uploaded instead of that Form-10-AC of Income-Tax Department is uploaded.
- iv. Incomplete details of Society/ Trust/ Company Members are uploaded.
- v. Only B.A. programme is running in the CALORX TEACHERS' UNIVERSITY and name of this university is now Sabarmati University without the permission of WRC, NCTE.
- vi. Recognition order of WRC for B.Ed. course in the name of CALORX INSTITUTE OF EDUCATION under the affiliation of CALORX TEACHERS' UNIVERSITY is uploaded but name of the affiliating university is now Sabarmati University which is without the approval of WRC, NCTE.
- vii. Recognition order of WRC for 4-Year Integrated B.A. B.Ed. course in the name of CALORX INSTITUTE OF EDUCATION under the affiliation of CALORX TEACHERS' UNIVERSITY is uploaded but name of the affiliating university is now Sabarmati University which is without the approval of WRC-NCTE.
- viii. Details of admitted students for all the teacher education programmes are not uploaded by the institution.
- ix. Affidavit of the management of the institution for details of land and built-up area is not uploaded.
- x. Details of Survey No. 14833/1 are mentioned in the land details but its mentioned 1483/1 in the address of the institution on this portal which is contradictory. The uploaded document is in Gujarati language. The institution is required to upload certified copy of land documents approved by the Competent Government Authority.
- xi. Land Mutation Certificate is not uploaded to verify the details mentioned in the portal.
- xii. LAND USE/ LAND USE CERTIFICATE (CLU) is not uploaded to verify the details mentioned in the portal.
