- (1) The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:
 - (i) The institution is required to submit the following documents in respect of its land and building located in its existing premises wherein recognition to all teacher education courses was granted by NCTE and copy of the latest verified complaint/investigation report in Case No. 13/2024 referred by Police Station, SOG, Rajasthan, Jaipur against the institution shall be sent to the institution for point-wise reply in this regard.
 - (ii) In response to WRC letter dated 16.07.2024, documents were sought by WRC, NCTE in connection with investigation of SOG of Rajasthan Police, Government of Rajasthan of which reply is awaited from the institution.
 - (iii) The institution is required to upload Building Plan approved by the Competent Authority of State Government indicating the Khasra/Plot/Survey No. and mentioning the total land and built-up area earmarked for each course being run in the premises and the demarcated land and built-up area for all the teacher education programmes. Information regarding running of all courses other than teacher education in the same premises is to be reflected earmarking its total land area and total built-up area.
 - (iv) The institution is required to upload the latest list of teaching staff for different recognized courses separately countersigned by the Registrar of affiliating body as per qualification contained in the NCTE Norms and Regulations as amended from time to time along with connected documents related to their detailed process of selection/appointment.
 - (v) The institution is required to upload the bank statement of last six months indicating the transaction of the salary / remuneration to its teaching staff appointed for various recognized courses separately.
 - (vi) The institution is required to upload the latest list/details of students admitted for all recognized courses.
 - (vii) The institution is required to upload Fire Safety Certificate issued by Fire Safety Department, Government of Rajasthan verifiable on the official portal of the Fire Department, Government of Rajasthan at URL https://lsgonline.rajasthan.gov.in/track_application.aspx
 - (viii) The institution is required to upload latest Non-Encumbrance Certificate issued by

- Competent Authority of State Government.
- (ix) The institution is required to upload Mutation Certificate and certified land documents issued by Competent Authority of State Government.
- (x) The institution is required to upload Building Safety Certificate in adherence of safety guidelines as prescribed by National/State Disaster Management Authority issued by Competent Government Authority.

Show Cause Notice u/s 17 (1) of NCTE Act 1993 be issued to the institution with direction to submit reply/documents supported with an affidavit within 21 days from the date of issue of notice.

(2) Further, Committee noted that despite letter dated 20.05.2024 followed by two reminders dated 26.09.2024 and 11.04.2025 respectively issued by WRC, NCTE to the institution in reference to order dated 10.04.2024 in LPA No. 264/2024 & CM APPL.19748-19749/2024 passed by Hon'ble High Court of Delhi, the institution did not comply/ deposit cost amounting Rs. 1,00,000/- to NCTE as imposed on the institution by the Hon'ble Court. More than one year has been passed from the date of court order.

In view of the above, Committee decided that appropriate legal action be taken against the institution for not complying with the direction of the court.

As per the details provided by the institution, the institution is not running (i) multidisciplinary course as per Regulation No.NCTE-Regl011/80/2018-MS(Regulation)-HQ dated 26.10.2021 and Public Notice No.NCTE-Regl022/16/2023-Reg. Sec-HQ dated 22/16/2023-Reg.Sec-HQ dated 5.2.2024.

The institution had not uploaded the reply of First Show Cause Notice dated 27.12.2024 and the reply of Final Show Cause Notice dated 31.03.2025 within the stipulated time.

- (i) The website of institution (https://madhavuniversity.edu.i) is not functional to verify the compliance as per NCTE Regulations, 2014 of para 7(14)(i) 8(6), 8(14) and 10(3) as amended from time to time.
- (ii) The University is required to submit Non-for-Profit Certificate issued by Govt. competent authority.
- (iii) 3) The University is required to submit Exemption Certificate (12A) issued under Income Tax Act, 1961.
- (iv) Information has not been submitted by the institution as per NCTE ITEP Regulations 2014 that "The institution shall have a Managing Committee constituted as per the rules of the affiliating University or concerned State Government, if any. In the absence of such rules, the institution shall constitute a Managing Committee on its own. The Committee shall comprise of the representatives of the sponsoring society or trust. academicians/ educationists. representatives of the affiliating University/Body and of the staff."
- (v) Information related to running of specific multidisciplinary programmes other than teacher education and its connected document needs to be uploaded by the institution. The institution has not submitted the latest order of affiliation for the academic session 2023-2024 for UG and PG and other programmes mentioned in the application.
- (vi) B.A.B.Ed./B.Sc. B.Ed.(Integrated) 4 year integrated course is recognized by NCTE for 2 Units intake (100), whereas institution has applied for B.A. B.Ed. Secondary (1 unit), Middle (1 unit), B.Sc. B.Ed. Secondary (1 unit), Middle (1 unit), thus total 4 Units intake (200).
- (vii) The institution has not submitted the essential details of students admitted. List of students admitted for 4 year Integrated B.A.B.Ed./B.Sc.B.Ed. course for the academic session 2023- 2024 countersigned by Registrar of concerned University is required to be submitted.
- (viii) The land has been taken on lease for 99 years from Govt. from the date 15.06.2012. The institution has not submitted information in the form of Affidavit as per National Council for Teacher Education (Recognition Norms and Procedure) Amendment Regulations, 2022, In the Principal regulations, in regulations 8 for sub-regulation (5), "(5) The institution or society shall upload an affidavit on Rupees one hundred stamp paper duly attested, by the Oath Commissioner or Notary Public stating the precise location of the land including khasra number, village, district, state, the total area in possession and the permission of the competent authority to use the land for educational purposes and mode of possession. In case of Government institutions, the affidavit shall

- be furnished by the authorized signatory. The affidavit shall be accompanied with the certified copy of land ownership or lease documents with the registering authority and the permission of the competent authority to use the land for educational purposes including approved building plan as per provision contained in sub regulation (4) of regulation 5."
- (ix) As per filled information on the application, name of Parent Organization mentioned as MADHAV UNIVERSITY, PINDWARA (SIROHI), whereas name mentioned in the NEC dated 04.01.2017 issued by Up Panjiyak, Bhavri as "Manav Bharti Charitable Trust", both names does not match each other.
- (x) Building plan uploaded in the transition application is not legible.
- (xi) The Fire safety certificate bearing No.01 is not showing in online LSG Department, Govt. of Rajasthan.
- (xii) Detail of Electricity Connection as a part of institution to be barrier free/accessible is not indicated in the transition application.
- (xiii) Information has not been submitted by the institution as per NCTE ITEP Regulations 2014 that "The institution must adhere to safety guidelines as prescribed by National Disaster Management Authority (NDMA)".
- (xiv) Name of society/trust mentioned in BCC as Manav Bharti Charitable Trust, whereas name of parent organization filled in the transition application portal as "MADHAV UNIVERSITY, PINDWARA (SIROHI)". Both names do not match each other. BCC is not certified by Competent Govt. authority/Govt. Engineer.
- (xv) The photos are not showing about Ramps, handrail and Lifts towards accessibility for persons with disability as per norms and standards.
- (xvi) The Multipurpose hall shown in the photograph uploaded does not seem to have been well equipped with adequate infrastructure and instructional facilities as per norms and standards.
- (xvii) The Playground shown in the photograph uploaded does not seem to have adequate infrastructure and instructional facilities as per norms and standards.
- (xviii) The institution shall submit the list of teaching staff duly approved and countersigned by its affiliating body.
- (xix) The institution shall submit the bank statement of last six months indicating the transaction of the salary / remuneration to its teaching staff.

In view of the above, the application for transition to ITEP is rejected.

The institution had not uploaded the reply of Final Show Cause Notice dated 20.01.2025 within the stipulated time.

- (i) The University has uploaded reply of SCN vide letter dated 27.05.2024. The University has uploaded ITM University, Gwalior Ordinance 65 A dated 23.12.2012 for Established three/four years undergraduate degree (CBSC Semester mode) that is B.Com. B.Sc.. The University has not uploaded Permission/ Approval issued by M.P. Private University regularity commission for running in the field of liberal arts, humanities, social sciences, commerce or mathematics, therefore as per NCTE Regulations, 2014, as amended from time to time, the application of the institution does not fall in the category of Multidisciplinary institution.
- (ii) The University has not mentioned which Khasra/Plot University Established. The address of the university mentioned in application form not match with recognition order for B.A. B.Ed.
- (iii) The university has not uploaded Authorization letter on the stamp paper as per admissible government rate.
- (iv) The university has not uploaded Not for Profit Certificate issued by Govt. Competent Authority. The university is required to upload Exemption Certificate (12A) issued by Govt. Competent Authority.
- (v) The University has not uploaded Affidavit Rs. 100/- in prescribed format regarding land documents. The University has uploaded land documents in respect khasra no. 500/3, 500/1, 500/2 village Bhatkhedi but the recognition for B.A. B.Ed. was granted to the university at khasra no. 118/11 Min, 113/3 village Turari . it is not clear which khasra no. land and which village university established or change the village prior permission.
- (vi) The University has not uploaded Mutation Certificate of land in respect of khasra no. 118/11 Min & 113/3, Village Turari.
- (vii) The University has uploaded Non-Encumbrance Certificate issued by Subhash Chaturvedi Advocate in different khasra no. The University required to upload NEC in respect khasra no. 118/11 Min, 113/3 issued by Govt. Competent Authority.
- (viii) The University has uploaded building plan but not approved and not proper readable. The institution is required to upload Building plan approved by Govt. Competent Authority mentioning name of institution, Name of course, Khasra no./Plot no., total land area, total floor wise built-up area, and earmarked land and built up area for each course being run in the same premises along with approval letter issued by Govt. competent authority.

- (ix) The institution has not uploaded Building Safety Certificate National/State Disaster Management Authority. The institution has not uploaded Fire Safety Certificate issued by Govt. Competent Authority.
- (x) The University has uploaded BCC in different khasra no. as per recognition order building situated at land khasra no. 118/11 Min, 113/3.
