- (i) The University has uploaded Affidavit dated 25.04.2025 Approved & signed by Registrar Acting Guru Ghasidas Vishwavidyalaya (Central University) Bilaspur (C.G.) 495009 India. From the document uploaded by the institution, it is observed that university has requested Director (CU I/II), Department of Higher Education, Ministry of Education, GoI, New Delhi so, subject to fulfilment of the condition to appoint teaching faculty required before offering the ITEP programme, the recognition is to be granted.
- (ii) It is also observed that university has uploaded staff profile of existing teaching staff those who are appointed by the university for different teacher education programmes being run. It is obligatory on the part of university which is governed by the rules and regulations of Government of India to appoint essential teaching faculty.
- (iii) It is observed from VT Report that the total land area mentioned in the Building Completion Certificate is 2553.41 sq.mtrs. and total built-up area is 1517.91. sq.mtrs. which is not as per the NCTE Notification published on 22.10.2021 and its Annexure No. 15, the provision no. 6(i)(b) for ITEP programme.
