The reply vide letter dated 27.11.2020 in response to SCN dated 30.09.2020 was considered by the Committee.

The institution is still deficient on the following grounds:

- i. The institution has submitted Building plan but not certified by the competent authority.
- ii. The institution has not submitted Non-Encumbrance Certificate (NEC), Land use Certificate (CLU) & Building Completion Certificate (BCC) issued by the competent authority.

In view of the above, Committee decided that Final SCN be issued u/S 17 of NCTE Act 1993 to submit reply supported with affidavit within 15 days from the date of issue of letter.

Further, Shifting Application dated 13.08.2024 of institution received in WRC office on 29.08.2024 was considered by Committee and the institution is still deficient on the following grounds:

- (i) The university has not submitted a **Fee for shifting of premises of Rs. 177000/- inclusive of GST** on the analogy of the processing fee of Rs. 40,000/- deposited by it at the time of submission of application on 09/09/2003. In its application form the institution has mentioned itself as a Government Institution. As per NCTE Rules 1997, as amended from time to time, **Government institutions are exempted from payment of the processing fee.**
- (ii) The university has not mentioned the demarcated land and built-up area for conducting the B.Ed. course in the land documents i.e. Building plan, NEC, CLU, BCC etc.
- (iii) In support of land documents, the university has submitted the leave and license agreement executed on 18 July 2024 between Sant Upasani Maharaj bahuudeshiya Sevabhavi Sansthan and the Director, Central Sanskrit University i.e. Private lease deed, which is not in accordance with the provision 8 (4) of NCTE Regulations

2014, amended vide NCTE Regulations, 2017 (Notification dated 28.04.2017) which stipulates as under :-

“2 b (4) No institution shall be granted recognition under these regulations unless the institution or society sponsoring the institution is in possession of required land free from all encumbrances on the date of application and the said land shall be either on ownership basic or on lease form the Government or Government institution for a period of not less than thirty years subject to the relevant laws of the concerned State or Union Territory. z

Provided that in cases of Central or State Government Institutions or Universities, recognition may be accorded for a period of five years, on land or premises, which is leased to them.

Provided further that such institutions shall be required to shift to premises with own land and building thereon, in conformity with the specification in these regulations within a period of five years from the date of recognition.

Provided also that in case of Central or State Government Institutions or Universities, recognition may be accorded on land or premises, which is leases to them for a period of thirty years or more.”

- (iv) As the land where the university has proposed to shift is not acceptable as per NCTE Regulations 2014, the other documents related to land and building are also not acceptable.
- (v) The university has not submitted Building plan for teacher education programme approved Building plan signed by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area with the measurements of the Multi-purpose Hall as well other infrastructural facilities such as classrooms etc.
- (vi) The university has submitted Photocopy of Land use Certificate in Marathi & English language issued by Grame Vikas Adhikari Game Panchayat Pimpri Sayyad, Tal. & Dist. Nasik dated 02.05.2023 & 18.05.2023 copy enclosed. But the Gata No. 1556 and 1399 are mentioned are mismatch with other documents.
- (vii) The university has submit Non-Encumbrance Certificate but not issued by the Competent Government Authority indicating that the land is free from all encumbrances.
- (viii) The institution has not submitted Certified copy of site plan with demarcated land area for running different education courses.
- (ix) The university has not submitted Building safety certificate from the Competent Government Authority.
- (x) The university has not submitted Fire safety certificate issued by the Competent Government Authority.
- (xi) The university has not submitted Certificate to the effect that the building is differently abled friendly from the Competent Government Authority.
- (xii) The university has not submitted Building Completion Certificate signed by the Competent Government Authority.
- (xiii) Status of NAAC.

In view of the above Committee decided that Show Cause Notice under Clause 8(9) of NCTE Regulation, 2014 be issued to the institution to submit reply supported with affidavit within 21 days from the date of issue of letter.
