The online application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time along with reply of SCN and the Committee observed as under:

- i. The institution has uploaded Extension of Provisional Affiliation vide letter issued on 07.03.2024 by its affiliating body i.e. MDSU, Ajmer for the session 2021-22 for B.A & B.Sc. in the name "Madhav college" instead of "SHRI MADHAV SHIKSHAK PRASHIKSHAN MAHAVIDYALAYA LADNUN". The institution is required to upload the affiliation in the name of applicant institution i.e. "SHRI MADHAV SHIKSHAK PRASHIKSHAN MAHAVIDYALAYA LADNUN" for the session 2022-23, 2023-24 and 2024-25.
- ii. The institution has uploaded Fire Safety Certificate issued by Sahayak Abhiyanta, Sa.Ni.Vi, Upkhand, Ladnun vide letter dated 28/06/2024. However, the institution is required to upload the Fire Safety Certificate issued online by Fire Safety Department of the Rajasthan Government which should be verifiable on the official web portal of the State Govt. at URL https://lsgonline.rajasthan.gov.in/track_application.aspx.
- iii. The Institution is required to mention/upload information of all the Members of the Society.

- vi. The latest certified copy of land documents have not been uploaded in respect of Khasra No. 923/23. New 1051/23 issued by Revenue Dept. Hence, the same needs to be uploaded.
- vii. The latest Building Completion Certificate (BCC) uploaded by the institution is issued by the Sarpanch, Jaswantgarh, Ladnun, Nagaur. The institution is required to upload BCC in

- prescribed format indicating Khasra/plot no., total land/built-up area certified by Govt. Competent Authority. It is also noted that the Khasra Nos. mentioned in the BCC and NEC are not same.
- viii. As per the Non-Encumbrance Certificate (NEC) uploaded by the institution in respect of Khasra no. 923/23, 1051/23 issued on 07/10/2024 by Tehsildar, Ladnun, the total land area is 5000 sq. mts. whereupon two institutions viz. (i) SHRI MADHAV SHIKSHAK PRASHIKSHAN MAHAVIDYALAYA AND (II) SHRI MADHAV MAHAVIDYALAYA are functioning. The demarcated land and built-up area for the two institutions and the earmarked land and built-up area for the Teacher Education programmes including ITEP is not mentioned. It cannot be ascertained whether the institution has requisite land and built-up area to conduct the proposed ITEP course along with two units of B.Ed. course. As per the Building plan uploaded by the institution in respect of Khasra no. 923/23, 1051/23 countersigned by Sahayak Abhiyanta, Sa.Ni.Vi., Upkand, Ladnun the total land area is 5000 sq. mts. whereupon the total built-up area is 4125 sq. mts. whereas, the uploaded NEC mentions two institutions viz. (a) SHRI MADHAV SHIKSHAK PRASHIKSHAN MAHAVIDYALAYA AND (b) SHRI MADHAV MAHAVIDYALAYA are functioning on this land. The demarcated land and built-up area for the two institutions and the earmarked land and built-up area for the Teacher Education programmes including ITEP is not mentioned in the building plan. It cannot be ascertained whether the institution has requisite land and built-up area to conduct the proposed ITEP course along with two units of B.Ed. course along with another institution. Hence, the institution needs to submit the earmarked land and built-up for the two institutions clearly.
- x. The institution has not uploaded all the pages of revised recognition order for B.Ed. course two years duration issued as per NCTE.
- xi. The institution has uploaded affiliation letter dated 07.03.2024 for B.A., B.Com. BCA. BBA B.Sc. and M.A. issued by M.D.S. University, Ajmer in the name of Shri Madhav College, Pabolav, Nagaur but the recognition for B.A. B.Ed./B.Sc. B.Ed. was granted in the name of Shri Madhav Shikshak Prashikshan Mahavidyalaya, Village –Jaswantgarh, Nagaur, both are different colleges which is not as per NCTE Regulations.
- xii. It is noted that the seal of the Notary is not appended on the Affidavit uploaded by the institution.
- xiii. The institution shall submit the list of teaching staff duly approved and countersigned by its affiliating body.
- xiv. The institution shall submit the bank statement of last six months indicating the transaction of the salary / remuneration to its teaching staff.
- xv. The website of institution has not been maintained and updated in compliance to Clause 7(14), 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as amended from time to time.

Name of the institution mentioned in the uploaded affiliation order does not match with the name mentioned in the application and recognition order of B.A.B.Ed./B.Sc.B.Ed. regarding Multidisciplinary programmes. iii. Details of admitted students of all teacher education programmes are not uploaded. iv. Address mentioned in the particulars of the institution matches with uploaded recognition order issued by NCTE for 4-Year Integrated B.A.B.Ed./B.Sc.B.Ed. course. The Kh. No.4021/982 is not mentioned in the existing recognition order for 4-Year Integrated B.A.B.Ed./B.Sc.B.Ed as per record of WRC. v. The institution has uploaded the duly signed manual copies of Jamabandi in r/o Khasra No. 1288 & 1285 for 7600 sq. meter and New Land documents Khasra No. 4021/982 total area 2000 sq. meter. The institution has not uploaded the Change of Land Use Certificate (CLU) Order in prescribed format as per Rajasthan Govt. Norms. vii. (a) The institution has uploaded the building plan in which some of the area like size of classrooms, multipurpose hall etc. are not readable. (b) The information not submitted by the institution as per NCTE ITEP Regulations that “A minimum number of four toilet blocks shall be earmarked by the Institution, two for students (one each for women and men) and two for staff members, including persons with disabilities. (d) The institution has uploaded the building plan including the new land Khasra no. 4021/982, that is shown that institution has been shifted premises without permission of the WRC. viii. (a) The fire NOC No18 is not found in online portal of LSG Department, Govt. of Rajasthan (b) The institution has not uploaded Building Safety Certificate by Govt. competent authority adhering safety guidelines as prescribed by National Disaster Management Authority (NDMA). (c) The institution has not provided the detail of Ramp, Lift, Electricity and Accessible Toilet for differently abled students/ persons. ix. - i. Uploaded Non Encumbrance Certificate in respect of land Khasra no. 30, 38/1, 39/1 issued by Tehsildar, Kota Development Authority, Kota (Raj.) dated 30.01.2025, wherein the seal of Tehsildar is not reflected.
- ii. The institution namely R.M.MEMORIAL WOMEN TEACHER TRAINING COLLEGE is not running any college in the field of Liberal Arts, Humanities, Social Sciences, Commerce or Mathematics, therefore as per NCTE Regulations, 2014, as amended from time to time, the application of the institution does not fall in the category of Multidisciplinary institution. As per the Order uploaded on the institution's website it is conducting the B.Ed. course with 100 intake since 2006. However, the institution has not mentioned this fact in the transition application. This college is not running any multidisciplinary programme. The institution has not uploaded any proof/documentary evidence regarding multidisciplinary institution.
- iii. The affidavit has been uploaded by the institution along with Patta. However, certified land documents in respect of Khasra no. 30, 38/1, 39/1 issued by Revenue Department are not uploaded, instead a copy of modified patta dated 01.03.2013 issued by Karyalay Nagar Vikas Trust, Kota is uploaded.

- i. There is no pending application/document/records for M.Ed. course in the office of WRC as claimed by the management of institution as on date. There is no such direction given by Hon'ble High Court Judicature for Rajasthan at Jodhpur as claimed by the Secretary of the management i.e. Baby Happy Modern School Shiksha Samiti to process the application for grant of recognition/permission to M.Ed. course, which is in confirmation of authentic order dated 07.03.2018 in S.B. Civil Writ Petition No.3384/2018 and order dated 17.03.2021 in S.B. Civil Writ Petition No.4718/2021 respectively downloaded from official website of Hon'ble High Court Judicature for Rajasthan at Jodhpur.

**MINUTES OF 414th (Part-I) MEETING OF WRC HELD ON
18TH– 21ST FEBRUARY, 2025**

The Committee considered the representation of institution for processing of M.Ed. application and observed as under-

- i. There is no pending application/document/records for M.Ed. course in the office of WRC as claimed by the management of institution as on date. There is no such direction given by Hon'ble High Court Judicature for Rajasthan at Jodhpur as claimed by the Secretary of the management i.e. MD Memorial Educational & Social Welfare Trust to process the application for grant of recognition/permission to M.Ed. course, which is in confirmation of authentic order dated 26.08.2021 in S.B. Civil Writ Petition No.11438/2021 downloaded from official website of Hon'ble High Court Judicature for Rajasthan at Jodhpur.
- ii. The Management of the institution itself has furnished false and fabricated information/document and mis-interpreted the decision of the Council taken in its Minutes of 55th and 59th General Body Meetings (not applicable for this institution), which leads to stringent legal action against the said management/society of the institution in accordance with the relevant provisions of law.

In view of the above, the Committee decided as under:

The correspondent of the management/society of the institution be warned not to repeat the same in future and to refrain from this kind of nefarious activities by submitting false and fabricated information/document, which is in violation of NCTE Act, Rules, Regulations, guidelines as framed from time to time.”
