The online application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time along with reply of SCN and the Committee observed as under:

- i. The institution has uploaded covering letter and Affidavit, however the institution has not uploaded information in the form of Affidavit as per National Council for Teacher Education (Recognition Norms and Procedure) Amendment Regulations, 2022 In the Principal regulations, in regulations 8 for sub-regulation (5), "(5) The institution or society shall upload an affidavit on Rupees one hundred stamp paper duly attested, by the Oath Commissioner or Notary Public stating the precise location of the land including khasra number, village, district, state, the total area in possession and the permission of the competent authority to use the land for educational purposes and mode of possession. In case of Government institutions, the affidavit shall be furnished by the authorized signatory. The affidavit shall be accompanied with the certified copy of land ownership or lease documents with the registering authority and the permission of the competent authority to use the land for educational purposes.
- ii. The website of institution https://kankuvijay.co.in has NOT been maintained and updated in compliance of all points mentioned under Clause 7(14)(i) 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as amended from time to time.
- iii. The institution has uploaded Fire Safety Certificate bearing No. MCP/AGNI/2024/4103 dated 05.03.2024 issued by Sahayak Agnishaman Adhikari, Nagar Parishad, Pali, Rajasthan. In lieu of submission of Fire Safety Certification issued through online LSG portal of Govt. of Rajasthan, institution has uploaded Fire safety certificate bearing No. MCP/AGNI/2024/4103 dated 05.03.2024 issued by Sahayak Agnishaman Adhikari, Nagar Parishad, Pali, Rajasthan. The institution is required to upload Fire Safety Certificate issued by Fire Safety Department, Government of Rajasthan verifiable on the official portal of the Fire Department, Government of Rajasthan at URL https://lsgonline.rajasthan.gov.in/track_application.aspx
- iv. The institution has uploaded Covering letter and Building Plan approved by Sahayak Abhiyanta, Panchayat Samiti, Pali, Rajasthan without indicating date. The institution is required to upload Building Plan approved by the Competent Government Authority indicating date with earmarked land and built-up area for each course and demarcated land and built-up area for teacher education programme being run in same premises.
- v. The institution has shown photographs regarding availability of Ramps and handrail towards accessibility for persons with disability. The photographs of ramps uploaded by the institution are not as per the standards which does not appear to be conducive for the disabled persons. The institution is required to submit geotag photographs with all angles clearly indicating the longitude and latitude with date of photograph.

- vi. The institution has shown photographs of Playground. The institution is required to submit geotag photographs of the Playground with all angles clearly indicating the longitude and latitude with date of photograph.
- vii. The institution has shown photographs of Toilet blocks by the institution, two for students (one each for girls and boys) and two for staff members. One common hand washing station, with four taps, in an open area shall be provided but institution has not shown Toilet block persons with disabilities. The institution is required to submit geotag photographs with all angles clearly indicating the longitude and latitude with date of photograph.
- viii. The institution has uploaded covering letter with Photograph of Building plan showing size of the Multipurpose Hall is 68.9 * 59.3 sq ft. The institution is required to submit geotag photographs of the Multipurpose Hall with all angles clearly indicating the longitude and latitude with date of photograph.
- ix. The institution has uploaded Covering letter and Land lease deed, Jamabandi (Mutation) in favour of Khasra No. 440/2 and institution replies that the Khasra No. 440/2 and 440 is same. However, as per the site plan uploaded with the Jamabandi, the institution has mentioned three different Khasra Nos. 440, 440/1, 440/2. The building of the institution is constructed on Khasra No. 440. There is discrepancy observed in the site plan.
- x. The institution has uploaded covering letter showing photographs of Library. The institution is required to submit geotag photographs of the Library with all angles clearly indicating the longitude and latitude with date of photograph.
- xi. The institution has uploaded the essential details of students admitted for first year. List of students admitted for 4 year Integrated B.A.B.Ed./B.Sc.B.Ed. course (year-wise) countersigned by Registrar of concerned University is required to be submitted.
- xii. The institution has uploaded Floor wise built-up area in Building Completion Certificate (BCC) as mentioned in the portal. The institution has uploaded the BCC for D.El.Ed. course only. The institution is required to upload BCC in NCTE prescribed format (17 points) issued by the Competent Government Authority with earmarked total land area and total built up area for all the courses being conducted in the premises.
- xiii. The institution has uploaded covering letter and says that as per NCTE ITEP Regulations 2014 safety guidelines as prescribed by NDMA is fulfilled. The institution has not submitted Building Safety Certificate issued by the Govt. Competent Authority.

i. In lieu of Non Encumbrance Certificate issued by competent authority, the institution has uploaded copy of fee receipts dated 29.02.2024 of office of Sub-Registrar, Nathdwara, Govt. of

- Rajasthan related to application made by representative of society for inspection and search document for the year 2020 to year 2024 along with advocate reports. The institution has not uploaded Non-Encumbrance Certificate issued by Competent Authority of State Government.
- ii. With regard to affidavit containing multiple khasra nos. of land, the institution has uploaded covering letter and replied that first patta No. 4101-04- Khasra No. 2813/2400, 2814/2522, 2829/2405, 2830/2522 total area 7.10 Bigha. Second patta No. 2009002083- Khasra No. 2893/1014 total area 5.00 Bigha. Third patta No. 665- Khara No. 2405/1014, 2522/2405 total area 3015 Bigha. All patta having total land 16.5 Bigha= 10.15 Acre. The institution has not uploaded any documentary evidence to suffice its claim that all the Khasra Nos. constitute a single plot of land where upon the institution is conducting all the courses.
- iii. The institution has uploaded the building plan approved by Sahayak Engineer, PWD Sub-Division, Nathdwara, Rajasthan and Sarpanch, Gram panchayat, Rajsamand, Rajasthan dated 25.01.2025. In reply of query, "institution has uploaded the building plan in which the date of the approval of the plan has not been mentioned by any of the authority", the institution has uploaded new building plan showing the name of institution "Nathdwara Institute of Biotechnology and Management (Ext)" for proposed programme bearing plot size as per site plan having total land area 41,101 sq.mts and total built up area 8604 sq.mts approved by Sahayak Engineer, PWD Sub-Division, Nathdwara, Rajasthan and Sarpanch, Gram panchayat, Rajsamand, Rajasthan dated 25.01.2025. The land area and built-up area for different programmes being run in the same premises have not been earmarked.
- iv. The institution has uploaded bank statement of last six months indicating the transaction of the salary / remuneration to its teaching staff, which does not suffice the fact that salary paid to its staff as per policy of Central/State Government/affiliating body and pay scales in accordance with the norms and standards of NCTE.
- v. The institution has uploaded covering letter with Building Completion Certificate approved by Civil Engineer (A.I.E), Dist.- Rajsamand, RJ dated 25.01.2025 and Sarpanch, Gram Panchayat office, Rajsamand, Rajasthan dated 25.01.2025. Uploaded new Building Completion Certificate is certified by Registered Civil Engineer (A.I.E), Dist.- Rajsamand, RJ dated 25.01.2025 and Sarpanch, Gram Panchayat office, Rajsamand, Rajasthan dated 25.01.2025, but not by competent Govt. authority. Out of total constructed area 10348.46 sq.mts. of the building, construction of ground floor area 5753.43 sq.mts. + first floor area 2850.83 sq.mts.=8604.26 sq.mts. have been shown as NIBM (Ext.) Building.
- vi. The institution has not uploaded requisite Fire Safety Certificate issued by Fire Safety Department, Government of Rajasthan verifiable on the official portal of the Fire Department, Government of Rajasthan at URL https://lsgonline.rajasthan.gov.in/track_application.aspx
- vii. After clubbing of different Khasra nos. with Khasra no.1014, where the proposed course is running, the total land area and total built up area earmarked for each course being run in the same premises has not been mentioned.
- viii. The website of institution has NOT been maintained and updated in compliance to Clause 7(14), 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as amended from time to time. In the category "Clause 7(14)(i)" reflected on the institutional web portal, course name "B.Ed." mentioned instead of B.A.B.Ed./B.Sc.B.Ed. The approved faculty list uploaded on web portal countersigned by Registrar of Affiliating University without date.
- ix. As seen in uploaded photographs of Multipurpose Hall, institution replies that the specified area for the Multipurpose Hall in the building plan is indeed smaller than the required size according to NCTE norms. However, specified area of multipurpose hall has not been shown in the uploaded building plan. The institution has submitted statement along with photos that the size

of the Multipurpose Hall at Khasra No. 1014 is 1,799 square feet. Additionally, an extra Multipurpose Hall with an area of 3,224 square feet has been incorporated as an extension part of the facility with all amenities. The institution has not uploaded any documentary evidence such as modified approved building plan, revised Building Completion Certificate etc. with regard to size of multipurpose hall adhering to NCTE norms.

In view of the above, the application for transition to ITEP is rejected.

However, details of admitted students have not been uploaded year-wise (Year-I, II, III, IV).
- iv. Not-for-Profit Certificate has not been uploaded by the institution.
- v. The website of the institution has NOT been maintained and updated to verify the compliance of all points in light of Clause 7(14)(i) 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as

The institution is required to upload Building Plan approved by the Competent Authority of State Government indicating the Khasra/Plot/Survey No. and mentioning the total land area and total built-up area earmarked for each course being run in the premises and the demarcated land area and built up area for the teacher education programmes.
- iii. The institution has uploaded photocopy of multipurpose hall with measurement of hall size 94 x 29 Sq.ft. The institution is required to submit geotag photographs of the Multipurpose Hall with all angles clearly indicating the longitude and latitude with date of photograph.
- iv. The institution has uploaded the photograph of the playground showing sports facilities. The institution is required to submit geotag photographs of the Playground with all angles clearly indicating the longitude and latitude with date of photograph.
- v. The institution has uploaded the photographs of toilet blocks for two for students (one each for women and men) and two for staff members, including persons with disabilities which seems to be in bad condition. The institution is required to submit geotag photographs of the toilet blocks with all angles clearly indicating the longitude and latitude with date of photograph.

- x. The institution has uploaded the photos of the Ramps and Handrail towards accessibility for person with disability. The institution is required to submit geotag photographs of the ramps and handrail with all angles clearly indicating the longitude and latitude with date of photograph.
- xi. The institution has uploaded latest order of 4 year Integrated B.A.B.Ed./B.Sc.B.Ed. course for the academic session 2023-2024. In lieu of latest order of affiliation in respect of all teacher education programmes for the academic session 2023-2024, the institution has uploaded copy of letter dated 01.06.2024 by Registrar, Maharaja Ganga Singh University related to list of selected students for counselling for the session 2024-2025.
- xii. Both the names are different. Therefore, as per NCTE Regulations, 2014, the application of the institution does not fall in the category of Multi-disciplinary Programmes.
- ii. Mutation certificate has shown for commercial educational purpose, it is not as per NCTE norms
- iii. Uploaded CLU is for commercial purpose; it is not as per NCTE norms.
- iv. Change of name of institution has not been done as per NCTE norms.
- v. The institution has uploaded Building plan approved by Sahayak Abhiyanta, PWD, Sub Division, Sawai Madhopur, Rajasthan and Secretary, Gram Panchiyat, Sawai Madhopur, Rajasthan dated 25.11.2016. Uploaded building plan is prepared by Consultant and approved by Sahayak Abhiyanta, PWD, Sub Division, Sawai Madhopur, Rajasthan and attested by Secretary of the management with signature without date.

- vi. The institution has uploaded 10A Form for Income Tax instead of 12A for income Tax Act, 1961 and not uploaded Not-for-Profit certificate approved by Govt. Competent Authority.
- vii. The institution has uploaded all members of Society/Trust approved by Registrar, Cooperative Department dated 18.09.2024.
