### Decision of WRC:

The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, proposal for shifting of premises and change of name of the institution and the Committee observed as under:

- (i) The institution has not submitted any compliance of Revised Recognition Order till date.
- (ii) The institution has not submitted any fee for Shifting of Premises of Rs.1,77,000/-
- (iii) The institution has not submitted Blue print of approved Building plan signed by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area with the measurements of the Multi-purpose Hall as well as other infrastructural facilities such as class rooms etc.
- (iv) The institution has not submitted Land Use Certificate issued by the Competent Government Authority to use the land for educational purpose.
- (v) The institution has not submitted latest Non-Encumbrance Certificate (NEC) issued by Competent Authority of State Government indicating that the land is free from all encumbrances.
- (vi) The institution has not submitted Certified copy of site plan with demarcated land area for running different courses.
- (vii) The institution has not submitted Building Safety Certificate in adherence of safety guidelines as prescribed by National/State Disaster Management Authority issued by Competent Government Authority.

And, notarized original affidavit of Rs. 100/- on non-judicial stamp paper by the management and Rs. 10/- non-judicial stamp paper by each selected/appointed faculty in the NCTE prescribed proforma.
- (xii) The institution has not submitted details of salary disbursed to the faculty along with six months Bank statement and account number of each faculty members.
- (xiii) The institution has not submitted copies of valid Fixed Deposit Receipts Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint operation mode with

<p><b><u>Decision of WRC:</u></b></p> <p>The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:</p> <p>(i) On the last occasion, recognition for B.Ed. course was withdrawn vide order dated 18.01.2024 in continuation of previous withdrawal orders dated 05.07.2012, 04.04.2013, 21.03.2018 and 11.07.2023 issued from time to time for not complying the appointment of requisite teaching faculty as per NCTE Norms and Regulations by the institution. The Appeal Committee vide order no. NCTE-APP1011/1st Mtg./2025-Appeal Section-HQ dated 31.01.2025 remanded back the case to WRC with the following directions:  <i>“... After perusal of the Appeal Report, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded to remand back the case to WRC with a direction to verify the documents submitted in Appeal from the concerned affiliating University. The Appellant institution is directed to forward to the WRC the documents submitted in appeal within 15 days from the receipt of order of Appeal and after receipt of the same the WRC to take further necessary action as per the NCTE Regulations, 2014 guidelines and amendments issued from time to time as per direction given herein above.”</i></p> <p>(ii) As per decision of 417<sup>th</sup> Meeting of WRC held on 07<sup>th</sup>-10<sup>th</sup> April 2025, the matter was referred vide letter dated 25.04.2025 followed by reminder letter dated 03.05.2025 to the Registrar and Vice Chancellor of University of Rajasthan (Affiliating body) with request to submit verification report related to appointed Principal and faculties pertaining to institution in accordance with NCTE Norms and Regulations as amended from time to time.</p> <p>(iii) The Committee in its 426<sup>th</sup> Meeting considered reply received on 29.05.2025 from University of Rajasthan vide letter No.Acad.II/2025/6139 dated 16.05.2025 and another letter vide No. Acad.II/2025/6185 dated 21.05.2025 signed by R.K. Jain, Additional Registrar, University of Rajasthan addressed to Regional Director, WRC, NCTE enclosing a photocopy of letter vide no. Acad.II/2020/37868 dated 16.12.2020 issued by R.K. Jain, Deputy Registrar, University of Rajasthan with copy endorsed vide letter no. Acad.II/2020/37869-74 dated 16.12.2020 signed by P.M. Gupta, Assistant Registrar (Academic-II), University of Rajasthan addressed to Secretary, Rajasthan Shikshak Prakashishan Sansthan Samiti, Shahpura Bagh, Amer Road, Jaipur related to list of teaching staff submitted by the institution to the affiliating university for approval. However, the University of Rajasthan has intimated vide aforesaid letter 16.05.2025 that the list of teaching staff was placed before the BOI meeting held on 26.11.2020 wherein the Committee has resolved to recommend that the list of teaching staff submitted by the college duly signed by the Principal and Secretary of the College be provisionally sent to NCTE, New Delhi with the conditions that the college will complete the approval of the</p>

<p>name of staff (teaching faculty) as mentioned in the list be sent to the NCTE, within three months failing which the NCTE will be informed to withdraw the list sent to it by the University.</p> <p>(iv) Accordingly, as per above decision of University, the provisional list so submitted by the said college, the same were signed by the University officials (the then Deputy Registrar and counter signed by the then Registrar after approval of the competent authority) and sent to NCTE for further necessary action. After that the said college were not submitted the list of qualified Teachers as well as Principal to the University for approval within stipulated time of 03 months, hence the Provisional list automatically cancelled which was sent to NCTE. Further, in the said letter dated 16.05.2025 of University of Rajasthan it is mentioned that due to the cancellation of building safety certificate of the college/institution by the Gram Panchayat Goner, the University has not given Provisional affiliation from session 2023-24 to till date.</p> <p>(v) In consideration of above observations made by University of Rajasthan (approving authority of Principal and teaching faculty) being affiliating body, it is revealed that the institution does not have any approved faculty as per requirements of NCTE Norms and Regulations as amended from time to time. The Provisionally recommended faculty list is not treated as valid now. Hence, the institution has failed to appoint the requisite teaching staff as per NCTE Norms and Standards, the ground on which recognition of B.Ed. course was withdrawn earlier.</p> <p>(vi) Moreover, the verified complaints against the institution for irregularities received from the Complaint Division, NCTE Hqrs. was considered by the Committee.</p> <p><b>In view of the above, the Committee decided that decision taken by Committee in its 399<sup>th</sup> Meeting of WRC held on 09<sup>th</sup> – 10<sup>th</sup> January, 2024 for withdrawal of recognition, issued vide order dated 18.01.2024 still stands and shall remain unchanged and same be communicated to institution and all concerned.</b></p>

Thereafter, a Show Cause Notice dated 07.11.2020 has been issued to the institution. However, the reply has not been submitted by the institution.  Further, a verified complaint vide letter dated 15.01.2020 has been forwarded by Complaint Division, NCTE, New Delhi, vide letter No. F.No. NCTE-C/PG011/13/2020-Complaint Section-HQ/129613 dated 22.04.2025 received in WRC on 09.05.2025 regarding misutilization of education qualification certificate submitted by Complainant during interview for the post of teaching faculty by the institution while not giving any appointment/selection letter to the complainant as alleged in complaint. It is evident that both the institutions as well as their parent bodies (society/trust) are situated and functioning on the identical address.

The Committee further noted that the applicant has uploaded the same documents pertaining to land such as Mutation, CLU, NEC, Building Plan, BCC, etc. in both the applications in order to mislead the WRC. Further, Khasra Nos. mentioned in the online transition portal for B.R. CHAUDHARY COLLEGE are 33/243, 33/244 and Khasra No. mentioned in the online transition portal for Bansal College of Higher Education is 33/244. In this case, Khasra No. 33/244 is identical in both institutions.

- (ii) The institution is conducting degree courses i.e. B.A. with 80 intake, B.Sc. with 70 intake, thus combined intake of 150. The sufficiency of land and built-up area for 150 intake of multidisciplinary courses and 400 intake (8 units) for proposed ITEP course cannot be ascertained.
- (iii) The name of the institution as well as parent body (society/trust) mentioned in the Building Completion Certificate (BCC) does not match with the name of the institution as well as parent body (society/trust) mentioned in the online transition portal. Further, the same is not approved by the Competent Government Authority.
