- (iii) The University has uploaded Notarized Affidavit on stamp paper of Rs. 100/- but the University has not uploaded Notarized Affidavit in respect of Land Documents in the prescribed format on stamp paper of Rs. 100/- .
- (iv) The earmarked land and built-up area for each course being run in same premises has not been mentioned in the Building Plan uploaded by the University. Seal and signature of the approving authority of the Building Plan is not legible. The institution is required to upload Building Plan approved by the Competent Authority of State Government indicating the Khasra/Plot/Survey No. and mentioning the total land and built-up area earmarked for each course being run in the premises and the demarcated land and built up area for the teacher education programmes.
- (v) The unconditional Building Safety Certificate of the whole building for the applied programme in adherence of safety guidelines as prescribed by National/State Disaster Management Authority issued by Competent Government Authority is to be uploaded.
- (vi) Total land area and built-up area earmarked for different courses is not mentioned in BCC. Total land area mentioned in the BCC is less than as required under NCTE norms for all courses. Course, the name of the institution mentioned as SNDT Womens University, whereas in the instant application, the name of the applicant institution mentioned as Shreemati Nathibai Damodar Thackersey Womens University Mumbai.
- (v) The institution has not uploaded the certified registered land documents. Further, the institution has not furnished information in the form of Affidavit as per National Council for Teacher Education (Recognition Norms and Procedure) Amendment Regulations, 2022, In the Principal regulations, in regulations 8 for sub-regulation (5), which states that “(5) The institution or society shall upload an affidavit on Rupees one hundred stamp paper duly attested, by the Oath Commissioner or Notary Public stating the precise location of the land including khasra number, village, district, state, the total area in possession and the permission of the competent authority to use the land for educational purposes and mode of possession. In case of Government institutions, the affidavit shall be furnished by the authorized signatory. The affidavit shall be accompanied with the certified copy of land ownership or lease documents with the registering authority and the permission of the competent authority to use the land for educational purposes including approved building plan as per provision contained in sub regulation (4) of regulation 5.”

The date of lease is 01/08/1938 for 999 years. The area of the property mentioned as 2912.78 sq. mts. This document is not a Mutation Certificate. Further, 2912.78 sq. mts land area is inadequate to conduct B.Ed., M.Ed. and proposed ITEP course.
- (vii) The institution has uploaded the lease letter issued by The Governor General of India as Lessor having land area 2912.78 sq. meter for a period 993 years from 10/04/1942. The institution has not uploaded Certificate of Land Use for Education Purpose (CLU) indicating the Survey No./Plot No./Khasra No. issued by the Competent Land Revenue Authority of State Government.

- (ii) Submitted Building Plan and Site plan with shifting application are in the name of Gyanveer University located at 285,286/1, 180/2,283, 290, 291/1, 278/279/2 Mara Imaliya, Sagar, Madhya Pradesh, which clearly established the fact that the institution has shifted on its own to Gyanveer University without prior permission of NCTE in violation of NCTE Act, Rules, Regulations and guidelines issued from time to time. **Explanation is hereby sought from the institution with appropriate documentary evidence along with affidavit.**

**In view of the above, the Committee decided that first Show Cause Notice be issued to the institution for M.Ed. programme to submit reply within 21 days from the date of issue of letter.**

**On scrutiny of application for shifting of premises, the following deficiencies have been observed:**

- (xiv) Submitted faculty list for M.Ed. course is not approved by the competent authority i.e. Registrar of Dr. Hari Singh Gour University, Sagar, Madhya Pradesh and 01 Principal, 01 Professor (out of 02 Nos. required), 02 Associate Professor and 06 Assistant Professors wherein S. No. 5,7, & 8 are without NET/Ph.D) are appointed. The appointed faculties are not as per provision under Clause-5 of Appendix-5 of NCTE Regulations, 2014.

**(1)** The application of the institution for change of name dated 13.02.2024 received on 22.02.2024 along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time along with the direction given by the Hon'ble High Court of Delhi at New Delhi in Writ Petition(C) No.3243/2025 vide order dated 17.03.2025 and the Committee observed as under:

- (iv) The institution is required to submit latest Non-Encumbrance Certificate issued by the Competent Government Authority indicating that the land is free from all encumbrances.
- (v) The institution is required to submit certified copy of Site Plan with demarcated land area for running different courses in the premises.
- (vi) The institution is required to submit Building Safety Certificate issued from the Competent Government Authority.
- (vii) The institution is required to submit Fire Safety Certificate issued by the Competent Government Authority for current year.
- (viii) The institution is required to submit Certificate to the effect that the building is differently abled friendly issued from the Competent Government Authority.
- (ix) The institution is required to submit Building Completion Certificate (17 points) in prescribed format signed by the Competent Government Authority which format is available on WRC's web portal.
- (x) The institution is required to submit latest approved appointed faculty/ies list for B.Ed. programme countersigned by the Registrar of the concerned university in the prescribed format available at WRC's official web-site as per provision of Clause-5 of Appendix-4 of NCTE Regulation, 2014 as well as point No. 8 of GOI No. 237 dated 09.06.2017.
