(iii) The institution has failed to appoint requisite number of faculties as per Appendix-V of NCTE Regulations, 2014 for M.Ed. approved intake of 50 as per prescribed qualification laid down under NCTE Norms and Regulations as amended from time to time.

In view of the above, the Committee decides that recognition for M.Ed. Programme be withdrawn u/s 17 of NCTE Act, 1993 with effect from the end of the academic session next following the date of communication of withdrawal order.

- (i) The institution is required to submit original latest approved faculty list in prescribed format as per provisions contained in NCTE Regulations as amended from time to time by Registrar of concerned affiliating body in the NCTE prescribed proforma along with requisite documents such as Affidavit on Rs.100/- stamp paper by the management regarding selection and appointment of faculty member on the recommendations of duly constituted selection committee with the approval of the concerned affiliating body, individual affidavit on Rs.10/- stamp paper by the appointed faculty member, copy of testimonials of appointed faculty, letter of approval of affiliating body relating selection/ appointment of faculty etc.
- (ii) The institutional website has not been maintained in compliance of all points as per Clause 7(14)(i), 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as amended from time to time.
- (iii) The institution has not submitted Form 'A' in original issued by Bank Manager of the concerned bank along with copies of FDRs towards Endowment and Reserve Fund in joint operation mode in reference to Clause 10 (1) of NCTE Regulations, 2014.

- Government Authority indicating that the land is free from all encumbrances.
- 5) The institution is required to submit Certified copy of site plan with demarcated land area for running different courses.

 - 7) The institution is required to submit Fire safety certificate issued by the Competent Government Authority.
 - 8) The institution is required to submit Certificate to the effect that the building is differently abled friendly from the Competent Government Authority.
 - 9) The institution is required to submit Building Completion Certificate signed by the Competent Government Authority.

WRC in its 379th Meeting held on 17th January, 2023 after consideration of Performance Appraisal Report (PAR) matter (2020-2021) recommended withdrawal of recognition in respect of 67 recognized Teacher Education Institutions. However, decision taken by WRC was not communicated to concerned institutions in view of Appeal filed by the numerous institutions before the Hon'ble High Court of Delhi bearing LPA No. 190/2022, which was allowed by Hon'ble High Court of Delhi vide order dated 13.03.2023.

Decision of WRC:

The said matter was carefully examined in light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee decides as under:-

The Committee considered the matter in the light of Hon'ble Supreme Court Order dated 06.07.2023 in SLP No.11756/2023 titled The National Council for Teachers Education Vs. Association of NCTE Approved Colleges Trust along with the legal opinion rendered thereupon by NCTE Standing Counsel in Hon'ble Supreme Court of India, the averments made by Legal Division and noted that the matter is sub-judice before the Hon'ble Supreme Court for its final disposal. Therefore, status quo be maintained with respect to PAR (2020-2021).
