The Order dated 29.08.2023 passed by the Hon'ble High Court of Punjab and Haryana at Chandigarh in CWP No. 17369/2023 titled as Syon College of Educatin & Welfare Society vs. State of Runjab and Anr. was perused by the NRC. The operative part is as under :-

"in the States of Punjab and Haryana all the recognitions granted by the NCTE appears to be conditional, granted in derogation of a direction issued by the Supreme Court in the case titled as "Adarsh Shiksha Mahavidyalaya vs. Subhash Rehangdale and others", (2012) 2 Supreme Court Cases 425 and that there is non-compliance of the direction by the Regional Committee of NCTE the Director of the Regional Committee be remain present in the Court on the next date of hearing."

The NRC after perusal of directions of Hon'ble Court decided as under :-
