However, it is not mentioned in the certificate that the proposed program (ITEP) will be funded by the Government. Certified copy of registered land documents issued by the registering authority is not uploaded. The uploaded document is a letter issued by the Administrator, Faridabad Complex Admn., Ballabgarh Zone regarding possession of land. As such, the institution has not submitted proper land documents. The Building Completion/Permission Certificate/ permission for occupancy issued by the Senior Town Planner is uploaded. However, the Building Completion Certificate is not in the prescribed format. The validity period of the Fire Safety Certificate has been lapsed. Renewed Fire Safety Certificate is not uploaded. The size of rooms, multipurpose hall, library-cum-reading room is not mentioned in the building plan. Earmarked area for the proposed programme is not shown in the building plan. Site Plan uploaded by the institution is not legible. The institution has not uploaded the Mutation Certificate issued by the Competent Government Authority. <p>Hence, the Committee decided to reject/refuse the application for B.A. B.Ed. The institution has not uploaded the mutation certificate issued by the revenue department. The institution has uploaded a self-declaration for Land Mutation. Non-Encumbrance Certificate uploaded is in regional language. Notarized English translated copy of the same is not uploaded. The building plan uploaded is approved by the Architect and not by the Competent Government Authority. The khasra no. mentioned in the building plan does not match with the khasra no. mentioned in the online application. The building Completion Certificate uploaded is issued by the Architect and not by the Government Engineer. The plot no./ khasra no. mentioned in the Building Completion Certificate does not match with the building plan and with the online application. Certificate to the effect that the building is differently abled friendly is issued by the Architect and not by the Government Authority concerned. <p>Hence, the Committee decided to reject/refuse the application for B.Sc. B.Ed.-Secondary (1 unit), B.A. B.Ed.-Secondary (1 unit) of the institution on the grounds mentioned above under Section 14/15 (3)(b) of the NCTE Act 1993.</p>

Notarized English translated copy of the land deed uploaded. As per the notarized translated copy of the land deed the land is in favour of Swami Swatantranand Memorial College HB No. 286, khasra no. 118 R, Killa No. 29 (7-14), out of which 3 Kanals 10 marlas and HB No. 286, khasra no. 123R/27/1 (4-0), 29 (7-19), 30/1 (1-17) Nos. 3 area 01 Kanals 0 marlas thus making 04 Kanals and 10 marlas which is grossly inadequate as required under NCTE Regulations 2014. Affidavit on Rs.100/- stamp paper regarding land is not uploaded. The affidavit uploaded is not regarding the land. Land Use Certificate issued by the Executive Officer; Municipal Council Dinanagaris uploaded, however, the details of Khasra Nos. for which the CLU has been issued, is not mentioned thereon. The institution has uploaded the land deed for HB No. 286, khasra no. 118 R, Killa No. 29 (7-14) and HB No. 286, khasra no. 123R/27/1 (4-0) 29 (7-19), 30/1 (1-17) Nos. 3 whereas the NEC submitted is for HB No. 286, khasra no. 123R/27/1 (4-0) 29 (7-19), 30/1 (1-17) Nos. 3 only. The institution has uploaded the same building plan as uploaded earlier. The blueprint of the building plan is not uploaded. As per the building plan, the khasra nos. are 119R, 122R and 123R whereas the land deed is uploaded for the land bearing Khasra no. 123R/27/1 (4-0) 29 (7-19), 30/1 (1-17) and 118 R, Killa No. 29 (7-14) and the NEC uploaded is for 123R/27/1 (4-0) 29 (7-19), 30/1 (1-17). The Building Completion Certificate in prescribed format is uploaded which is signed by the Architect (Building Designer) and not by the Competent Government Engineer. The Khasra nos. mentioned in the building completion certificate are 119R, 122R and 123 R whereas the institution has not uploaded the land deed for Khasra no. 119 R and 122 R. The institution has not uploaded the certificate to the effect that the building is differently abled friendly issued by the Competent Government Authority. <p>Hence, the Committee decided to reject/refuse the application for B.A. B.Ed.-Preparatory (1 unit) of the institution on the grounds mentioned above under Section 14/15 (3)(b) of the NCTE Act 1993.</p>
