- As per information filled on the online transition application portal, the institution had uploaded the status of affiliation letter dated 01.03.2024 wherein it stated that Teerthanker Kunthnath College of Education running B.Sc.B.Ed. programme with one unit is the constituted College of Teerthanker Mahaveer University whereas name of proposed college is Teerthanker Kunthnath College of Education, Teerthanker Mahaveer University.
- The institution had also uploaded a letter dated 01.03.2024 stating that 109 more programmes (Under-Graduate, Post -Graduate and Ph.D.) in the disciplines of Medical, Dental, Nursing, Physiotherapy, Pharmacy, Paramedical, Engineering, Management Fine Arts, Agriculture, Physical Education, Humanities & Science approved by the respective regulatory bodies are running in the University, however, the institution has not uploaded the relevant document in this regard.
- Sri Prem Prakash Memorial College and Teerthanker Kunthnath College of Education are two different colleges and affiliated with Teerthanker Mahaveer University, Moradabad (Private University).
- As per records, the institution which is recognized for B.A. B.Ed. / B.Sc.B.Ed. programme by NRC in under the name & style of Teerthanker Kunthnath College of Education and not in the name of Teerthanker Kunthnath College of Education, Teerthanker Mahaveer University. Hence, name of the institutions is mismatching.


In view of above, the Committee decided that Show Cause Notice be issued under Section 15 of the NCTE Act, 1993 to the institution to submit reply within 21 days from the date of issue of show cause notice.

The original file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee and the Committee observed the following:-

The office of NRC is in receipt of applications to issue OTPRMS certificate/s to students who have obtained B.Ed./M.Ed. degree from the institutions located in the different States under domain of Northern Regional Committee (NRC) particularly in Haryana.

2. It is noted that in most of cases the jurisdiction of the affiliating University which was mentioned in the initial recognition order or revised recognition order, has now been modified by the State Government of Haryana & Uttar Pradesh due to its State Policy. As such, the affiliating Universities at the time of recognition from NRC and at the time of award of degree to the applicant are different.

3. The candidates/students applying for OTPRMS are *inter-alia* required to fill the name of the University which the Institution is affiliated with at present. While examining cases for issuance of OTPRMS certificate, it has been observed that one institution namely Lakshya College of Education, Panipat, Haryana recognised by NRC was initially affiliated to the Kurukshetra University, which was later on affiliated to the Chaudhary Ranbeer Singh University, Jind from the Academic Session 2016-17 onwards as per Memo No. 20/09-2014-UNP(1) dated 22nd June 2016 issued by the Director, Higher Education, Government of Haryana, Panchkula, Haryana .

Hence, the Committee decided to authorise the Regional Director, NRC to issue the OTPRMS Certificate to the students consequent upon change in the name of the affiliating body/University, in respect of all the institutions, covered under jurisdiction of Northern Regional Committee, on receipt of an Undertaking from
