The institution has also filed W.P. No. 12008/2024 before the Hon'ble High Court of Delhi and Hon'ble High Court has passed order dated 30.08.2024 in the said petition thereby directing NRC to file short reply. In compliance of the order passed by the Appellate Authority dated 27.02.2024, the NRC examined the documents submitted by the institution and found the reply of the institution deficient on the following grounds: -
