			<p>and also at is liberty to verify other documents from the concerned competent authority and the Appellant institution was directed to forward to the NRC the documents submitted in appeal within 15 days from the receipt of the order of the Appeal.</p> <p>4. In compliance of appeal order, the institution has submitted documents and the same have been received in the office of NRC on 26.04.2024 which is after lapse of 15 days as directed by the Appeal Committee.</p> <p>5. The institution has also filed W.P. No. 12008/2024 before the Hon'ble High Court of Delhi and Hon'ble High Court has passed order dated 30.08.2024 in the said petition thereby directing NRC to file short reply.</p> <p>In compliance of the order passed by the Appellate Authority dated 27.02.2024, the NRC examined the documents submitted by the institution and found the reply of the institution deficient on the following grounds: -</p> <p>(i) The institution has submitted photocopy list of faculty members dated 05.02.2024 i.e. of one HOD + 15 teaching staff which is approved by Registrar Raja Mahinder Pratap Singh University, Aligarh, Uttar Pradesh. However, the institution is required to submit original faculty list duly approved by the affiliating university.</p> <p>(ii) The institution has not submitted the letter from the affiliating body for approval of the faculty list.</p> <p>(iii) The institution has not submitted downloaded copies of documents from the website of the institution with hyperlinks of the same as per provisions of 7(14) of the NCTE Regulations, 2014.</p> <p>Hence the Committee decided that a SCN be issued to the institution to submit reply within 21 days.</p> <p>Further the Legal Counsel be directed to apprise the Hon'ble High court accordingly.</p>

The recognition of the institution was withdrawn vide order dated 11.10.2023.2. The institution had filed an appeal before the Appellate Authority of the Council under section 18 of the NCTE Act, 1993 against the withdrawal order dated 11.10.2023 passed by the Northern Regional Committee (NRC).3. The Appellate Authority vide its order dated 10.11.2023 remanded back the case to NRC with a direction to verify the faculty list submitted in appeal from the concerned Affiliating University and also at is liberty to verify other documents from the concerned competent authority and the Appellant institution was directed to forward to the NRC the documents submitted in appeal within 15 days from the receipt of the order of the Appeal.4. The institution submitted reply dated 23.11.2023 received on 30.11.2023 and reply dated 18.03.2024.5. The institution has also filed W.P. No. 13918/2024 before the Hon'ble High Court of Delhi and Hon'ble High Court has passed order dated 09.10.2024 in the said petition thereby directing NRC to file counter affidavit. <p>In compliance of the order passed by the Appellate Authority dated 10.11.2023, the NRC examined the documents submitted by the institution and found the reply of the institution deficient on the following grounds: -</p> <ol style="list-style-type: none">(i) The institution submitted a colored photocopy of the approved staff list. The institution is required to submit original faculty list duly approved by the affiliating university.(ii) The institution has not submitted the letter from the affiliating body for approval of the faculty list.

However, the Committee noted that the institution has not submitted the required documents viz. the original faculty list duly approved by the affiliating university, proof with regard to enhancement of infrastructure and instructional facilities and FDR of Rs. 7 lakh and 5 lakhs towards Endowment Fund and Reserve Fund prepared in the joint name of the Regional Director, NRC and institution/management.</p> <p>Hence the Committee decided that a SCN be issued to the institution to submit reply within 21 days.</p> <p>Further the Legal Counsel be directed to apprise the Hon'ble High court accordingly.</p>
