<p>Decision of NRC</p> <p>The original file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee and the Committee noted the following:</p> <ul style="list-style-type: none"> In compliance of the Appeal Order No. 89-1056/E-249714/2022 Appeal/5th Meeting 2022/APPLNRC202214263 dated 16.06.2022, the matter was considered by the NRC in its 416th Meeting held on 20th December 2023 and the Committee agreed to consider the request of the institution for restoration of its intake from one unit to two units which was initially granted and later reduced vide RPRO on its own request subject to submission of the certain documents. Accordingly, the First Show Cause Notice was issued to the institution vide No. NCTE/NRC/HP-256/416th Meeting/Sl. No. 37/2023/224138 dated 12.01.2024. The institution had submitted its reply in response to First SCN dated 12.01.2024 received in NRC on 28.02.2024 & 31.01.2024.

<p>Decision of NRC</p> <p>The original file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee.</p> <ul style="list-style-type: none"> In compliance of the Order dated 23.08.2024 passed by the Hon'ble High Court of Delhi in Contempt Petition No. 1332/2024, the representation dated 06.06.2023 submitted by the institution has been considered by the NRC and the Committee noted that NRC in its 207th meeting held from 27th to 30th November 2012 decided that the order of withdrawal of recognition stands for M.Ed. & C.P.Ed course and accordingly an Order dated 24.02.2013 was issued to the institution <i>inter-alia</i> conveying the withdrawal of recognition for C.P.Ed. course on the request of the institution <i>vide</i> letter dated 02.05.2012. Since the recognition of the institution has already been withdrawn by NRC, the representation dated 06.06.2023 is found devoid of merit and disposed of accordingly. <p>The institution be informed and the Legal Counsel be requested to submit the compliance report before the Hon'ble High Court accordingly.</p>
