The Court directed to fulfil the deficiencies of infrastructure and unapproved faculty before giving admission in session 2017-18 and also directed NCTE to conduct inspection in 2018. Institution did not complied directions of the court. <br> 7) An inspection was conducted by NCTE under section 13 of NCTE Regulation on 07.10.2021. <br> 8) The Regional Committee considered the VT report as per Court direction and made the following observations: <br> 1. On the basis of infrastructure only one basic unit of 50 students is recommended by the Visiting team. <br> 2. VT team is silent on the issue of approved |

Hence committee decided not to grant additional unit of 50 students to the institution.

The institution's original recognition order with respect to 50 seats (one unit) intake, is concerned the committee hereby decides to continue the previous recognition order issued to the institution on $1^{\text {st }}$ June, 2017 for annual intake of 50 seats (one basic unit of 50 students) subject to the compliance of following conditions:

1. Faculty List approved by the affiliating University.
2. Salary statement of the faculty members of last six months.

Hence, Show Cause Notice under Section 14/15 (3)(b) of the NCTE Act, 1993 be issued to the institution to submit their reply alongwith supported documents accompanied with notarized affidavit of Rs. 100/- on Nonjudicial stamp paper by the authorized representative of the Management within 30 days from the date of issue of show cause notice.
