The institution vide letter dated 20.03.2019 had requested to close the **Programme** run by the institution. Now therefore, the Committee decided to issue letter seeking following clarifications: -

1. As per records the Principal of the institution vide letter dated 20.3.2019 informed that there is less admission and management thought of utilising the infrastructure for other purposes. Accordingly, the SRC withdrawal the recognition of the institution vide order dated 30.07.2019. Now after a gap almost 4 years the institution has requested for restoration of permission to the institution. The institution is required to clarify about the same with a copy of proper Resolution of the Management explaining the reasons for seeking restoration after such a huge lapse of time.

The institution is also required to submit the following documents:-

- 1. The institution is required to submit certified copy of land documents issued by concerned Tehsildar /Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents)
- 2. The institution is required to submit an attested/notarised copy of Land Use Certificate issued by the Competent Authority.
- 3. The institution has not submitted a copy of Non-Encumbrance Certificate issued by the Competent Authority. The institution is required to submit an attested/notarised copy of Non Encumbrance Certificate issued by the Competent Authority.
- 4. The institution is required to submit an attested/notarised copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)
- 5. An attested/notarised copy of site plan showing all the plot/Survey No. mentioned in the land documents in one location alongwith land area and built-up area.
- 6. The Institution is required to submit an attested/notarised copy of Building Completion Certificate issued by the competent authority.

- 13. The institution shall be required to submit an Affidavit clearly stating status about land & building and Management (Society/Trust) at the time of recognition and its present status giving following details
 - (i) Details of land & building available at the time of recognition with the Institution.

The Committee considered the representation dated 01.06.2023 and observed that the institution is not recognised by the SRC, NCTE and at this stage the application of grant of recognition cannot be considered in light of 55th GB meeting decision taken by the council which are as under:-

In light of the above, the Council members unanimously decided the following: -

- I. At present, there are several institutions which have been recognised by the Regional Committees of NCTE wherein programme, other than diploma level Programme, are running. An Expert Committee be constituted to devise the modalities for conversion of these recognised institutions into multidisciplinary institutions in line with NEP 2020.
- II. The applications pending before the Regional Committees of NCTE shall not be processed further. Hence, all such pending applications before RCs at any stage of processing be returned along with the processing fee to the concerned institution(s).
- III. In the cases where the applications are being processed/ reopened as per the directions of the Hon'ble Court (s), the concerned Regional Committee shall file a review / appeal before the Hon'ble Court(s) alongwith stay application against the order passed by the Hon'ble Court (s) for processing of application(s) in view of the decision of the Council as taken in II above.

In light of the above, the SRC cannot considered the representation of the institution.

The University further requested to recognize the University as affiliating University for all the Education and Physical Colleges existing in erstwhile Prakasam District, Andhra Pradesh and to update University in the database of the NCTE and also display the colleges in NCTE website as soon as possible.

The Committee decided that name of the changed University may be updated in the records of the NCTE and the concerned affiliating body be informed accordingly after due verification of the records.
